 - This document shows the 2022 HUD CoC Competition Timeline publicly posted on the WIBOSCOC website. For renewal projects, APR submissions were due August 15th for review & ranking. Bonus or new projects were required to submit their applications by August 26th. *E-snaps* submission is separate from the local competition deadline.

- Screen Shot Dated 8/26/22:
 - This document shows the updated 2022 HUD CoC Competition Timeline publicly posted on the WIBOSCOC website. Bonus or new project submission deadline was extended until August 31st. This also includes the explicit language about August 31st being the deadline for the CoC's local competition for CoC Program funding.
