Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

In our most recent APR, it shows that we reported a 100% unit inventory, but a 82% bed inventory rate. All of our units were full, however we had anticipated needing more beds to serve families. Most of the participants have been single though, so we reduced the number of beds in the upcoming year from 28 to 21. This should show an increase in the bed inventory percentage rate.

There was some funding that was returned/not utilized in leasing costs during the grant year. That was the result of an inaccurate estimation of the number of bedrooms needed. When we wrote the application, we anticipated needing more units for families, which would mean needing larger apartments and more leasing dollars. However, when pulling people off of the coordinated entry prioritization list, we find more singles in need of assistance. In order to move forward and not have that continue to happen, program staff are meeting with financial staff on a monthly basis to watch the funding more closely and determine if any budget reallocations need to be made.

# 1. Provide a description that addresses the entire scope of the proposed project.

WD proposes a renewal to our PSH Project to address needs of the chronically homeless (CH) in Eau Claire, WI. Our Housing First Program is the only program available for CH in the area. Our goal is to focus on helping our target population, CH individuals and families, access & sustain permanent housing.

We follow the Housing First model by offering CH clients housing without preconditions, such as sobriety, mental health treatment, or minimum income. We do not require service participation, rather accept applicants regardless of their sobriety/use of substances, completion of treatment, or participation of services. Applicants receiving services are prioritized by highest needs & greatest barriers. WD follows the BOS Order of Priority which emphasizes CH & VISPDAT score.

We currently lease 15 units for both singles and families, in a scattered site project. These units house approximately 21 of the CH population. WD will provide services including transportation/transit assistance, case management, employment & education services, all which will address unstable employment histories; and, financial counseling (part of life skills training) from WD staff will address the lack of financial competency. By increasing income in stable housing, significant barriers to homelessness may be addressed (mental health/substance abuse issues), and over time, minimized. Our informal partnership with ADRC to assist with completing social security application forms, and both DVR & CDC (Career Development Center) to assist with both assessing & securing employment opportunities for disabled workers has been beneficial with assisting this population.

Though we continue to cultivate local resources to assist in funding our PSH program, CoC funds are an invaluable source of revenue necessary to continue operations. In addition to helping provide for operating expenses, the CoC funding promotes a local vibrant and active Continuum, an important resource for all service providers in our community.

Referrals come from our Dairyland Prioritization List & local Coordinated Entry system, and from local partners, including CoC member agencies, shelters & other partner agencies using the coordinated assessment. WD currently does a lot of collaboration with AIDS Resource Center of Wisconsin (ARCW), Lutheran Social Services, Catholic Charities, The Community Table, Sojourner House, outpatient treatment centers, as well as many other resources.

Additionally, program goals include 82% of persons housed by the project will remain in permanent housing or exit to permanent housing at the end of the operating year. Additionally 56% of adults will either maintain or increase their

total income at the end of the operating year/project exit.
