We do not require service participation, but instead accept applicants regardless of their sobriety/use of substances, completion of treatment, or participation of services. All those receiving services are prioritized by highest needs and greatest barriers on the Dairyland prioritization lists.

Currently, we lease 10 units of PSH for both singles and families, in a scattered site setting. These units house 10 of the most vulnerable of the CH population. WD will provide services including transportation/transit assistance, case management, employment and education services, all which will address unstable employment histories; and, financial counseling (part of life skills training) from WD staff will address the lack of financial competency. Our goal is to help our clients increase their income while in stable housing so that other barriers can be addressed (mental health/substance abuse issues), and over time minimized. We have informal partnerships with ADCR to assist with completing social security forms, and both DVR and CDC for assessing and securing employment opportunities for disabled adults.

Funding from the COC is crucial to the success of this program. Although we are able to seek out small, additional grants when we can, in no way are those resources enough to cover all the costs of housing the CH in our area and providing them with the resources necessary to maintain housing.

Referrals for our project continue to come from the top of the Dairyland CE Prioritization WISP and non-WISP lists. Our project works very closely with CCS (Comprehensive Community Services), Lutheran Social Services, The Community Table, Sojourner House, outpatient treatment centers, as well as many other resources.

Program goals include 82% of persons housed by the project will remain in permanent housing or exit to permanent housing at the end of the operating year. Additionally 56% of adults will either maintain or increase their total income at the end of the operating year/project exit.


