 - o Works with clients within WOW region
 - Overseen by BOS
 - o 18-24 years old, category 1,2,4
 - Transitional housing
 - Hebron house connects with landlord
 - Goal graduate youth to rapid rehousing program
 - Shared housing model for unit in west bend
 - Long term program, still in early stages
 - o Works with Karls place, youth and family project etc
 - Refer to program
 - Coordinated entry auto refers based on age
 - Directly contact Adam if preferred
 - o Works similar to other rapid rehousing with prioritization
 - Accepts people off list
 - Completes 'move on' assessment to determine needs and barriers, determine if TH or RRH program eligibility
 - Enter transitional housing on day of intake if needed
 - Current enrollment
 - 14 total households in WOW region (5 w/ children, 9 singles)
 - Total since Nov. 32 households in YRRH and 7 YTH
 - Found permanent housing for 10
 - Units are challenging to find, want more in Washington and Waukesha
 - Case management: client to client. TH units require weekly in home case management, RRH depends on situation (in home usually a few times a mo)
 - Cannot assist 17 or younger (minors) will refer to other minor agencies
 - Shared housing model approved by HUD and BOS

- Can assist more people with this model in this situation
- Exceptions to some certain rules with this program (Leigh is expert for this)
- Shared housing
 - Follow state regulations with size and bedroom, mostly depends on household size
 - The client makes their own decision
 - Can cohabitate but haven't tried to pursue that (Waukesha is single men, Washington is single women or family)

EFSP Update

- John Schiraj (United Way)
 - Phase 40 distributed to all counties across the county
 - \$14,718 for WA county
 - No new applicants, only ever had FPWC and FRIENDS apply
 - Past practice has been to divide 50/50
 - FPWC request for funding
 - Two locations = more utilities
 - Housing first model
 - Hoping to continue the work that has been provided with Phase 40
 - Favor of 50/50 split
 - FRIENDS request for funding
 - Also in favor of the split with FPWC
 - Families are homeless because of category 4 but also because of financial need
 - Housing first model
 - Motion to approve EFSP budget split directly in half

- Dayna Berger (Family Promise) Jackie presented
 - o RRH 12 within family and single setting
 - HPP increase of people in need continuously (larger and larger rental arrears)
 - Up to 35 households

Emergency Shelter

- Jacklyn Rabuck (Family Promise)
 - o Families 28 individuals total
 - New build means no supportive transitional housing for families but will continue again with new building finished
 - o Singles 24 individuals within shelter
 - 4 within transitional housing updates were given
 - Waitlist
 - Trend for both men and women in need
 - More men than women being served
 - Services provided
 - Over 100 assessments for programs
 - 81 walk ins
 - Motel vouchers 22 vouchers for 29 people, 31 nights of shelter
 - Housing Hotline 855 calls so far
- Yvonne MacDonald Hames (FRIENDS, Inc.)
 - Maintained capacity
 - 2 large families, 4 individuals
 - Looking to serve more individuals, change in capacity eventually
 - Hotline has been getting a lot of calls for homeless individual referrals from Milwaukee county
 - Lots of calls for those in need of rent assistance

- Kate Markwardt WISBOSCOC
 - Statistics on Racial Equity and Homelessness
 - HUD emphasizes that local Coalitions need to identify and understand racial disparities within their region
 - What can be done to further understand and utilize the knowledge re these disparities
 - WA coalition less homelessness than the BOS in general
 - Marginalized disparities based on race / ethnicities = more likely to experience homelessness
 - However: white people are seeking out / entering projects more than POC (carries over to other marginalized identities as well)
 - Use this data as a starting place in our work to address disparities within our community
