### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

ADVOCAP will use funds to provide Rapid Rehousing (RR) as the only RRH provider within the WinnebagoLand CoC. With use of VI-SPDAT assessment & a coordinated entry process, eligible individuals and families will be offered assistance through RR to quickly exit homelessness & move into & maintain permanent housing. Targeted participants will have barriers such as lack of stable income, poor rental history and legal issues that will be addressed after housing is obtained. This Housing First project will serve single individuals as well as families with children (4 singles/3 families) totaling 10 persons/beds. As a sub-recipient, LAW staff and volunteer attorneys will work with participants on legal issues affecting their employability, mainstream benefits access, receiving public assistance as well as other stabilization issues. ADVOCAP and LAW staff are in place & are experienced with the multiple barriers facing the homeless. Once enrolled, hh's will create an ISP that addresses their goals and barriers, and ADVOCAP case managers will connect them to area resources. HH's will be assisted in registering for all appropriate mainstream resources, health insurance, WIC, food stamps, etc., as well as enrolling minor children in school, and training/education opportunities for adults. Counseling services for DV, sexual assault, mental health, AODA issues, physical health, and parenting will be done through county programs, community hospitals and clinics. Access to available public transportation, after-hour transportation programs, and alternative ride share options will be addressed. 
By our determination dated May, 1967, you were held to be exempt from Federal Income Tax under the provisions of section 501(c)(3) of the Internal Revenue Code.
