HUD funding is needed as ADVOCAP is the only agency in the local CoC to provide RRH services, utilizing the coordinated entry system already in place. With use of the VI-SPDAT, eligible households are prioritized & offered assistance to quickly exit homelessness & move into permanent housing. The project does not target a specific group but ensures persons are not screened out because of barriers such as poor housing history, criminal records, mental health or substance abuse issues & employment-related problems. All participants meet HUD's homeless criteria. This Housing First project will serve single individuals as well as families with children totaling 10 persons/beds. HH's have the choice of where to live, based on each HH's individual needs and proximity to school, work & family support systems. Once enrolled, HH's create an ISP that addresses their goals and barriers & ADVOCAP case managers will assist HH's in registering for all appropriate mainstream resources, including health insurance, WIC, food stamps, etc., as well as enrolling minor children in school, and with exploring training/education opportunities for adults. Counseling services for DV, sexual assault, mental health, AODA issues, physical health, and parenting will be done through county programs, community hospitals and clinics. Access to available public transportation, afterhour transportation programs, and alternative ride share options will be addressed. ADVOCAP operates employment programs as well as basic education programs, and all HH's will have access to individualized assistance to increase their employability. As appropriate, HH's will work with Forward Services to obtain W2, FSET and financial assistance. Legal Action staff who are "SOAR" trained will assist eligible households in obtaining SSI/SSDI benefits. Life skills training is offered through the Extension Rent Smart program. Each HH will have the opportunity to connect with resources based on their need. Participants will be provided with rental assistance over a long-term basis while they deal with their issues & achieve a level of stability that will enable them to afford their permanent housing & stabilize their situation to avoid future homelessness. Outcome goals include participants remaining in permanent housing at the end of their participation & achieving increased income from employment &/or other sources. CoC money will be used for rental assistance, case management and administrative costs.
