3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

ADVOCAP Fond du Lac Rapid Rehousing Project serves Fond du Lac County, primarily the City of Fond du Lac, (population 42,970) using a Housing First model. It provides case management & wraparound support services to help the homeless move into & maintain permanent housing. All clients come through emergency shelters or off the street & meet HUDs homeless definition. The project does not target a specific group & ensures persons are not screened out because of barriers. Most come through Solutions Center, a local emergency shelter. The previously completed program year served 53 clients, 16 HH made up of 18 adults & 31 children, & 4 single individuals. 3 were parenting youth. Although not a targeted population, 50% of the adults have a history of domestic violence. We will provide rental assistance for 6 units on a scattered site basis. Tenants have the right to choose their own location & may transition in place. We will also provide 2 two-bedroom agency owned units & will calculate match based on allowable rent & costs. COC funds will be used to provide case management for all eight households. Participants work with a case manager to voluntarily develop a client-centered goal/self-sufficiency plan, access mainstream resources to deal with their needs & stabilize their situation to obtain/maintain permanent housing. They participate in life skills training through a program known as RentSmart. Employment is a major goal of the program & ADVOCAP Employment staff work with participants to develop job skills & help them obtain/maintain employment. Persons will exit the program when able to maintain permanent housing, often within a year. ADVOCAP uses the VI-SPDAT model for assessing & enrolling clients through a coordinated assessment process involving the local CoC, which includes homeless service providers, public agencies, & others. The agency follows adopted WIBOSCOC standards for prioritizing persons for the RR program & adopted standards for providing services. Staff meet with clients as often as necessary, weekly at first, then less often as stability is reached & maintained. ADVOCAP is a Community Action Agency able to provide a vast array of services to help the homeless become self-sufficient & overcome barriers, operating housing programs since 1998. Participants will successfully obtain & maintain permanent housing, achieve housing stability through lifskills training & increased income, & access mainstream resources. Funding for this program through the CoC program is essential as it serves single individuals as well as families who have significant barriers requiring extended supports before being able to move into permanent housing. These barriers include poor housing history with previous landlords, criminal records, mental health or substance abuse issues & employment-related problems.
