ADVOCAP Fond du Lac RRH serves HH with or without children using a Housing First model. It provides CM & wraparound support services to those enrolled through coordinated entry, prioritizing those with highest barriers. ADVOCAP is the only provider of RRH. All clients come through emergency shelters or off the street & meet HUDs homeless definition. The project does not target a specific group but ensures persons are not screened out because of barriers such as poor housing history, criminal records, mental health or substance abuse issues & employment-related problems. We provide rental assistance for 6 units on a scattered site basis & 2 two-bedroom agency owned units. All participants have the right to choose their own location based on their needs & proximity to work, school, family & support systems & may transition in place once program participation is ended. Participants work with a case manager to voluntarily develop a client-centered goal/self-sufficiency plan, access mainstream resources to deal with their needs & stabilize their situation to obtain/maintain permanent housing. Counseling services for DV, sexual assault, mental health, AODA issues, physical health, and parenting will be done through county programs, community hospitals and clinics. Access to available public transportation, after-hour transportation programs, and alternative ride share options will be addressed. As appropriate, they are connected to Forward Services for W2. FSET and financial resources. They participate in life skills training through Extension's Rent Smart program. ADVOCAP operates employment programs as well as basic education programs, and all HH's will have access to individualized assistance to increase their employ ability. Legal Action staff who are "SOAR" trained will assist eligible households in obtaining SSI/SSDI benefits. Each HH will have the opportunity to connect with resources based on their need. Participants will be provided with rental assistance over a long-term basis while they deal with their issues & achieve a level of stability that will enable them to afford their permanent housing & stabilize their situation to avoid future homelessness. Outcome goals include participants remaining in permanent housing at the end of their participation & achieving increased income from employment &/or other sources. Coc money will be used for rental assistance and administrative costs. We serve people who are experiencing homelessness.
