## 1. Provide a description that addresses the entire scope of the proposed project.

This project provides permanent supportive housing to two families at a time who meet the definition of chronically homeless, utilizing the Housing First model. Through the intake & assessment process the case manager will verify that the families have at least one adult with a diagnosed disabling condition & meet the length of time homeless criteria. Priority will be given to those households with children who have been homeless the longest & have the most significant barriers to obtaining housing. ADVOCAP previously purchased & rehabbed a duplex with 1 2-bedroom unit & 1 3-bedroom unit to be utilized for this purpose. 1 unit is fully accessible for persons with physical disabilities. The budget includes operations funds to pay for utilities, insurance, allowable supportive services & case management. Case management, co-enrollment in agency programs, & community connections will be used to increase housing stability. Labor Education Training Center staff are housed in our Berlin office & run the employment & training programs for our 3 county service area. They will work with interested participants on resume writing, completing employment applications & interviewing skills. DVR staff are also housed in our Berlin office & available to those who are interested in their program. Forward Services, a state W2 TANF provider is also housed in our office & available to determine eligibility for mainstream resources, such as W2 TANF benefits, Food Share, etc. Staff are in the process of becoming SOAR trained to assist households with SSI/SSDI applications. Legal Action of WI staff work with participants on civil legal matters, such as child support, drivers license reinstatement, past evictions, unemployment, garnishments, etc. Staff work on the basis of strengths-based case management & are trained in assisting in obtaining benefits. Goals are to increase earned & total income. Complementary supports are intended to help families improve their quality of life, integrate into the community & achieve self-sufficiency. This includes engagement in meaningful activities in the community, life skills & income supports, assistance with employment & training & educational opportunities. The supportive services budget includes dollars for food, mental health services, outpatient health services, substance abuse services & transportation. 
