3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

HUD funding is needed because ADVOCAP is the sole agency within the local CoC to provide Rapid Rehousing (RR) services & uses the WIBOSCOC coordinated assessment system in place for enrolling program participants, as does the agencies making referrals. With use of VI-SPDAT, eligible families are prioritized & offered assistance to quickly exit homelessness & move into permanent housing. All participants will meet HUD homeless eligibility requirements. We adhere to all WIBOSCOC adopted standards in providing services to those enrolled in RRH. Hh's will select their own units. The project will serve 14 hh. 10 hh will receive rental assistance to lease housing of their choice, from either a area landlords, or an agency owned unit; another four involve agency-owned units with no rent assistance requested. We will pay 100% the 1st month with tenants paying 30% of adjusted income in subsequent months. CoC funds will be used for case management/supportive services for all 14 households. Once enrolled, hh's will create an ISP that addresses their goals and barriers, and case managers will connect them to area resources. In efforts to eliminate their barriers, hh's will be assisted in registering for all appropriate mainstream resources, as well as enrolling minor children in school, and exploring secondary education opportunities for adults. Counseling services for DV, sexual assault, mental health, AODA issues, physical health, & parenting will be done through county programs, community hospitals and clinics. Transportation issues will be addressed, including access to available public transportation, after-hour transportation programs, and alternative ride share options. We operate employment & training programs as well as basic education programs, & all hh's will have access to programs & individualized assistance to increase their employability, & appropriate hh's will work with Forward Services. Each hh will have the opportunity to connect with services to address their needs. Our goal is that participants will exit into permanent housing & increase their total income. We have operated a HUD ESG-funded RR program for over 10 years, & recruited landlords in cities served to provide sustainable affordable, scattered-site rentals. Using a Housing First model, housing locations are identified that meet the needs of the household, such as proximity to school, work, family & support networks being nearby. Staff are trained in HQS to ensure the decency of the rental prior to assistance being provided, & are experienced in calculating rents & determining rent reasonableness. Case managers will work with clients to establish a self-sufficiency plan, develop short & long-term goals & monitor the participants to resolve crisis issues prior to them negatively affecting their housing. They will connect the households to resources related to benefits, employment services, including co-enrolling them in agency programs.
