Additional NOFA Releases

1) HUD is pleased to announce the release of the **FY 2019 Mainstream Voucher Program Notice of Funding Availability (NOFA)** (FR-6300-N-43). Public Housing Authorities (PHAs) may apply for funds through this NOFA to assist non-elderly persons with disabilities. <https://www.hudexchange.info/news/hud-makes-150-million-available-to-public-housing-authorities-for-mainstream-vouchers/>

HUD will post a pre-recorded webinar on the NOFA within the next two weeks. The webinar will be posted to the **Mainstream Voucher Program webpage** and will be announced via the **Mainstream Vouchers listserv**.

Applications are due **September 5, 2019** at 11:59 PM Eastern Time and must be submitted through **Grants.gov**. To find the NOFA on Grants.gov, search by the CFDA number: 14.879.

2) On July 2, 2019, HUD released the **Specialized Housing and Services for Victims of Human Trafficking Notice of Funding Availability (NOFA)** to grants.gov.

Through the funds available under this NOFA, HUD's Office of Special Needs Assistance Programs (SNAPS) and the U.S. Department of Justice (DOJ) Office for Victims of Crimes (OVC) are promoting collaboration between Continuums of Care (CoCs) funded by HUD and organizations funded by DOJ to address the housing and service needs of victims of human trafficking. are strongly advised to carefully read the criteria for application submission paying attention to the requirements and submission due date and time.

HUD funding estimates for planning, bonus and DV bonus

- CoC is eligible for CoC Planning Funds. This is not competition, it is not ranked. It is a separate application. The total amount available is: **\$302,110**
- BONUS funds are available to the Balance of State CoC. The funds are not a guarantee, but rather available for projects to apply for. More information will be released soon about the new project application process. The total amount available is: **\$503,516**
- The Balance of State CoC is eligible to apply for more DV BONUS funds. These are set-aside funds and do not impact the Tier threshold or ranking process. There will be more about this opportunity released in the near future. The total amount available is: **\$972,277**

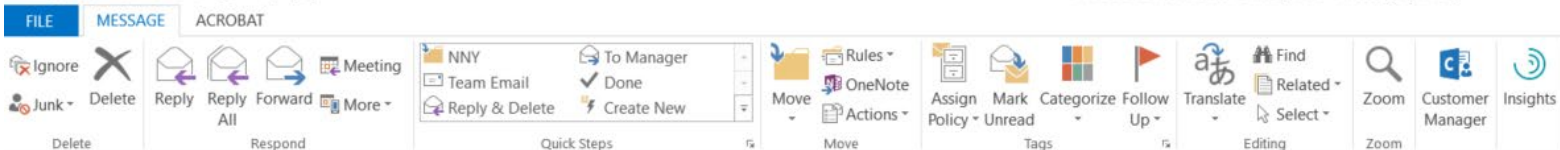
