

Indianhead After Hours Plan with Attached Grid

The West Indianhead CoC covers the following counties: Burnett, Clark, Taylor, Rusk, Washburn and Sawyer. The After Hours Plan was developed by organizations in each county that serve people experiencing homelessness. This Plan will be reviewed and updated annually by the Indianhead CoC, with input from the relevant agencies in each county (i.e. shelters, law enforcement, hospitals, etc.). To ensure consistent implementation of the Plan in each county, this document will be provided to law enforcement, hospitals, emergency shelters, domestic violence agencies/shelters, and other organizations identified by CoC members.
