Coordinated Entry Committee:

- We have 58 people on the CE committee, that are putting in a lot of time and effort to continually improve and update CE.
- There are 11 work groups under the CE Committee.
 - DV, Evaluation, Implementation, Marketing, Youth, Other Systems of Care, Outreach, Prevention/Diversion, Veterans, Data Management, Assessment and prioritization.
- We meet on the 4th Wednesday of the month from 2-3:30pm.
 - Updated and approved the committee charter.
 - Member Representing an EHH or COC funded agency or other member of a BOSCOC agency. Has full voting rights.
 - Participant No eligibility requirements, Can vote on work groups, but not at the committee level.

- CE conversation at the end of every meeting.

Coordinated Entry HMIS transition:



- So far (knock on wood) it's going smooth from the feedback I have received. If you are having any issues making CE referrals or filling COC or EHH program openings, please contact me or your local SSO staff (CE Lead).
- All homeless Coordinated Entry referrals must go through the WI BOSCOC Non-HMIS referral tool beginning April 1st, 2021 until the homeless prioritization lists are built in the new HMIS system (Clarity) estimated to be around the beginning of June 2021 for homeless referrals and August 2021 for prevention referrals.
- Just a reminder, now that Clarity is live, you may see some of your CE referrals
 that were in Service Point. Please DO NOT try and do anything with these until
 the CE systems in Clarity are built.
- All agencies must retain a copy of the WI BOS Pre-screen, Client Rights & Responsibilities, and HMIS ROI forms to be uploaded into the new HMIS system (Clarity) when it is available.






- All CoC and ESG funded housing programs must fill their program openings via Coordinated Entry.
- When filling a housing program opening, all housing programs must connect with your Local Homeless Coalition's CE Lead (SSO staff) to compare the last Service Point prioritization list ran on March 31st with their current Non-HMIS prioritization list and serve the highest prioritized household.
- If the highest prioritized household is not served, it must be clearly documented why the highest prioritized household was not served and this must be communicated to your CE Lead (SSO Staff).
- To remove (accept/cancel/decline) a referral, please contact your local coalition's CE Lead (SSO Staff).
 - They will need the clients unique id, date of removal, and reason for removal.

Coordinated Entry HMIS transition (continued):



- Once the CE systems in Clarity are built, agencies will then transfer the referrals we have made to the temporary systems over.
