3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Jefferson County Transitional Housing Program (THP) operated by Community Action Coalition for South Central Wisconsin, Inc. (CAC) provides 18 homeless households with housing for up to 24 months using the Housing First model. Participants selected must be Homeless Category 1, 2 or 4 and on the Jefferson County prioritization list. Scattered site apartments in Jefferson and rural Waukesha counties are provided to participants but leased by the CAC. This program is goal-based and involves intensive case management, including supportive services most, but not all of which, are outlined in Section 7B. Although supportive services are voluntary for participants, they are strongly encouraged. Program success is captured by CAC's capacity to help participants maintain stable housing and move into permanent housing upon exit. CAC expects 80% of households entered will exit to permanent housing, such as subsidized housing. Participants entering THP generally enter by first receiving motel voucher due to Jefferson and rural Waukesha counties' lack of shelter facilities. Each year, several participants who are living on the streets or spending nights in uninhabitable conditions seek assistance. Households participating in THP benefit from case management and referrals to other service providers. This results in participants receiving necessary services, and increased self-determination. Participants come to the CAC with a variety of financial, health, employment, and personal needs that often prevent them from maintaining housing. Caseworkers refer participants to needed services and provide limited financial assistance for the following supportive services: AODA counseling, continuing and adult education opportunities, employment assistance, transportation, childcare, medical co-payments and dental assistance, and vouchers for groceries. CAC has an income measure of 60% for participants. All program resources used carefully tracked by THP's caseworkers. Although participants are not required to, they are encouraged to attend monthly educational group meetings, acquire a savings account, maintain renter's insurance, and participate in weekly household visits with caseworkers. Coordinated Entry (CE) in Jefferson County is completed at CAC; all participants are screened and referred to the appropriate agencies or organizations for assistance. All eligible households are encouraged to apply for the program on the same day. CAC is an active member of the Wisconsin Balance of State Continuum of Care (CoC) and follows their Transitional Housing Standards. CAC is the lead agency for the Jefferson County CoC and a member of the Housing Action Coalition of Waukesha County, Inc. Currently, there are no emergency shelters and limited resources for homeless individuals in Jefferson and rural Waukesha counties. CoC support is unique because funding is provided for both housing and supportive services; this is critical for successful outcomes.
