3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

CAC will provide 9 permanent supportive housing scattered site units in Waukesha County for chronically homeless (CH) individuals using the Housing First model. Participants selected for the program have been assessed for need using the VI-SDPAT and submitted for the community priority list. As of 8/10/18, the Balance of State Waukesha County prioritization list consists of 102 individuals (11 CH) and 24 families (0 CH). This shows a great need for housing programs like Project WISH for single individuals experiencing homelessness in Waukesha County.

Individuals at the top of the list for Singles are housed if their status meets the definition of chronic homelessness in accordance with HUD regulations. CAC will lease units and sign Memorandums of Understanding with landlords who are willing to provide apartments for the program. Leased apartments follow HUD regulations and are deemed affordable if they fall below Fair Market Rent and meet Rent Reasonableness standards. An Environmental Review of each unit is also conducted and must be passed. CAC will then sublease to participants who sign an agreement with the agency to abide by leasing terms and pay subsidized rent based on HUD's formula. CAC will even assist participants in procuring furniture, household goods, and cleaning supplies for their homes.

Voluntary supportive services offered will form a comprehensive approach to help chronically homeless individuals maintain housing. Project WISH's ultimate goals are to assist participants in achieving self-sufficiency, increase self-determination, and maintain housing until the participant successfully exits the program and secures stable housing elsewhere. Participants will be offered case management as well as assistance on an as-needed basis for the following: mental health services, AODA treatment, health care costs (i.e. copays), transportation assistance (i.e. bus passes), education (i.e. GED testing), and assistance with childcare costs.

CAC's caseworkers offer case management that varies in intensiveness based on each participant's willingness to take part in the services offered. Intake and assessment are completed to determine Individual Service Plans (ISPs) that include goals such as securing long-term income, referral to community-wide services, and enrollment in public assistance programs. Case management also includes financial consultation focusing on repairing credit, and budget planning for future permanent housing options such as subsidized housing. The expected outcomes are 80% of participants will remain in or exit to permanent housing and 75% of participants over age 18 will maintain and/or increase their total income upon program exit by the end of the grant period.
