- 1. June Meeting Minutes No changes or additions. Approved.
- 2. Housing Navigation Team Update Isaac Hoffman developed Housing Navigation Guide to assist staff working with individuals looking for housing, since the process can be difficult. 2 purposes as a training guide for new workers and also to be used as a public training. Let Isaac or one of the committee members know if you would like them to present this tool to your staff. The committee members are: Dillon Mader from Project Proven, Alicia Place from the La Crosse School District, Anthony Larsen of CVI, Julie McDermid from The Exchange, Kish Hudson of ILR and Fue Yang, formerly of ILR.
- 3. Houska Park Encampment Jay Odegaard Cameron Park encampment had been creating problems for nearby businesses. City looked for an area where individuals could camp to get them away from downtown, put in port-potties, washing stations, trash cans, electricity, etc. 37 tents are there as of this morning. Will look into the possibility of having a phone available in case of an emergency. City has not put a cap on the number of people that will be allowed to live there. Not sure what will happen in the winter, whether everyone will go to shelters or if some people will opt to stay at the park over the winter. ILR is going there 2x weekly minimum for outreach meals will be provided on Thursday and Sundays, with more hopefully coming –

no more meals at Cameron Park. Portable shower units were considered but won't be provided at this time due to cost. This encampment is being run on a shoestring budget – if any agencies are able to provide camp showers or any other resources to help, it would be great. Individuals are asking for yoga or sleeping mats, pillows and flat sheets.

- 4. Balance of State Updates: Kristi Bechtel Diversity and Inclusion Committee has been created, Kim Cable is chairing. Hoping to recruit more diversity on the BOS Board. Trainings will be offered on Motivational Interviewing again. August 12 Training Day Friday August 13 will be Quarterly Meeting. Training to be offered on helping clients deal with finances. Check it out on BOS website
 - A. Delegate Election Results Jeanne Meyer is new delegate to BOS.
- B. YHDP NOFO Update Mary Jacobson Locally Kristi and Mary will be attending meetings to put together the grant application through our BOS. Should be long process app is due by the end of July but beyond that is extensive planning.
- 5. CCEH Transition Updates Mary Kay Wolf Transition team has met with City the City is hiring a homeless position within the Planning Dept. May include landlord liaison role. Would not be replacement for manager role in CCEH. Would serve only the City due to funding sources.
- 6. Day Center and RHYMES Update Lauren Journot Location will be 11th and King Building. Hiring for positions for Shelter Director, will then hire advocate positions. No longer calling the Day Center by that name, haven't decided on name yet.
- 7. PIT Count Planning Becky Koske July 22nd look for an email in early July re: a planning meeting, possibly Tuesday afternoon the 6th to plan routes and teams etc.
- 8. Homeless Connect Planning Update Becky Koske No event last year also won't be doing traditional event this year. We have the La Crosse Center reserved for 2022. This year we will join with Hearts in the Park to provide an event in late October/early November. Planning will continue. Please reach out to Becky if you want to help with the planning.
- 9. Consumer Advisory Council Update CAC (Le Anne Martinez and Randall Brown) will be involved in planning of the above event, set up a booth to reach out to homeless individuals. Randall is taking his Peer Specialist exam soon. Continuing outreach with homeless individuals to offer help.
