- 2. Q&A with Coulee CoC Delegate Nominees Two nominees introduced themselves. Families First of Monroe County Executive Director Jeanne Meyer. Director of Social Services at Salvation Army Krista Coey. Mark has sent out questionnaires completed by both candidates, please review. Voting link will be sent out soon.
- 3. Balance of State updates Kim Cable.
 - New Board Chair has been elected Lisa Haen. Cheryl Dietrich is new Vice-Chair.
 - COC competition is expected to start at the beginning of summer.
 - Review of recent trainings, upcoming trainings. Trauma and Resilience and Motivational Interviewing have been very popular. Carrie Poser will send emails re: upcoming trainings.
 - EHH Grant should be hearing soon. YWCA has been the lead agency on this grant.
 - Emergency Housing Vouchers La Crosse County and City will not be receiving any vouchers at this time.
 - Desk monitoring is in place for WIBOSCOC sub-grantees. New contracts will be sent to local COC's for sub-grantees.
 - Wisconsin will receive \$10 million as part of the American Rescue Plan's homeless allocation.
 Webinars will be scheduled to discuss the use of these funds watch for an email from Carrie Poser.
- 4. EHH Lead Agency Lauren Journot YWCA is happy to continue as lead agency for this grant. ESP, HPP funds, sub-recipients get some of the funds, not just YWCA. Emergency housing, prevention and

rapid re-housing. A vote was taken and the vote was unanimous that the YWCA continue as Lead Agency for the EHH Grant.

- 5. Coulee CoC Action Plan Progress Kim Cable. We were assigned several areas to work on, including adopting policies regarding Fair Housing, Involuntary Family Separation and Discrimination, and Education of Children Experiencing Homelessness. A vote was taken and the vote was unanimous to adopt these policies.
- 6. Day Center and Youth Shelter updates YWCA. Day Center still no building located yet. 11th and King location still a possibility. Youth Shelter location in place, posted supervisor position. 1st Wednesday of the month meeting on this project contact Jane Beschwamel if you would like to attend. Grant funds must be spent by April 2022.
- 7. CCEH Transition/Restructuring Mary Kay Wolf and Mary Jacobson Recent survey reviewed results. Survey supported combining the Collaborative, CoC, and Coalition. Respondents favored having a project manager, with the PM housed at local government agency. There were many answers regarding the role of project manager. Meeting with the mayor this Friday, mayor may be pursuing the hiring of a Housing position, county will also be present. Survey results will be sent out to all.

 - Kevin Hundt Coulee Tenants United hosting 2 info sessions re: homelessness and housing.
 June 21 and one other date in June. For more info contact Coulee Tenants United. Info will be sent out closer to the date.
 - Abby Waters Great Rivers Hub 2 community health positions open, both are Spanish speaking positions.
