# **CoC Competition**

- Unclear what HUD will do with FY20 CoC Competition. Hoping for renewal only. Waiting on legislative authority (HEROES ACT)
- FY21 CoC Competition will likely occur May-June 2021
- Updating the final product CoC Project Scoring Tool, plan to score projects as if there were a competition for information purposes

### **CoC Organizational Activities**
