CAC will use CoC funds to provide 9 permanent supportive housing scattered-site units in Waukesha County for chronically homeless (CH) individuals using the Housing First model, including case management. Participants selected for the program are assessed for need using the VI-SDPAT and placed on the community prioritization list. Individuals at the top of the list are housed if their status meets the definition of chronic homelessness in accordance with the HUD Interim Rule. Program participants are involved in finding their housing as housing choice is an important factor in their program progress. CAC leases units and signs Memoranda of Understanding with landlords who are willing to provide apartments for the program. Leased apartments follow HUD regulations and are deemed affordable if they both fall below Fair Market Rent and meet Rent Reasonableness standards. An Environmental Review of each unit is also conducted. CAC subleases available units to participants who sign an agreement with the agency to abide by leasing terms and pay subsidized rent based on HUD’s formula. CAC even assists participants in procuring furniture, household goods, and cleaning supplies for their homes. Voluntary supportive services offered form a comprehensive approach to help chronically homeless individuals maintain housing. Project WISH’s program goals are to assist participants in achieving self-sufficiency, increase self-determination, and maintain housing until the participant successfully exits the program or secures stable housing elsewhere. Participants are offered case management as well as assistance on an as-needed basis for the following: mental health services, AODA treatment, health care costs (co-pays), transportation assistance (i.e. bus passes), education (i.e. GED testing), and assistance with childcare costs. Case management carries in intensiveness based on each participant’s willingness to take part in services offered. Intake assessments are completed to determine Individual Service Plans (ISPs) that may include securing long-term income, referrals to community-wide services, and enrollment in public assistance programs. Case management also includes financial consultation focused on credit repair and budget planning for future permanent housing options, such as subsidized housing. CAC expects that by the end of the grant period, 80% of Project WISH participants will remain in or exit to permanent housing, and 75% of participants will maintain and/or increase their total income upon program exit. Project WISH is the only permanent supportive housing program in Waukesha County. Currently, this program is over capacity and there are still 51 chronic individuals on the prioritization list in the county. CoC funding is required to ensure the continuation of this very necessary program. Caseworkers will refer clients to services such as Latino Academy of Workforce Development, Wisconsin Department of Workforce Development, Wisconsin Works, and FoodShare Employment and Training for workforce development and employment services. CAC has existing relationships with these organizations that make it easier for us to help our client connect with these programs. These programs can help clients gain higher paying employment that increases their chance of exiting the program into permanent housing. CAC Caseworkers will help clients apply to programs such as food stamps, veteran benefits, WIC, and WI shares. We connect clients to ADRC and United Health.
