In this grant cycle, CAC had many positive outcomes for clients. Our Local COC along with WHEDA were able to set aside Moving on Vouchers, also known as EHV vouchers. This gave opportunities to households who were enrolled in our Transitional Housing Program to move into a more permanent housing option if they qualified and wanted to apply. Four of the five households that were exited from our program in this contract year were assisted with those vouchers. Because of this permanent housing option, many of our landlords who held leases with CAC, wanted to allow their residents to stay in the units, and were willing to resign leases with the current residents. On top of the four households who received EHV vouchers, one more household was able to maintain their current residence without assistance, and also were able to sign leases with their current landlords, along with an additional household that signed a lease right before the new grant cycle started. This led to an interesting issue as during this grant cycle we were down six units, and locating new units during this period are hard to find. Jefferson County housing rental inventory is low and coupled with the Covid-19 crisis there were less units available than in an average year. Added barriers to housing proved to be more difficult over the grant period for program clients who have large barriers to housing such as rental history and criminal background. CAC was hard at work to find new units and by the end of the grant period were able to locate and secure new units, and are currently assisting 8 of the 10 households in our new contract, with a new household leasing up this week. Since hiring a new caseworker toward the end of 2021, the caseworker has increased the household numbers from January 2022 to April 2022. She has also established herself into the Jefferson County community and has made outstanding progress towards housing navigation and landlord engagement/mediations. With the Covid-19 crisis, the lack of fair market rent coupled with less households moving due to the increased assistance several of the program clients have moved from transitional housing (leases previously held by CAC) to permanent housing at the same unit being the lease holder. As most communities will most likely comment, one barrier that continues to be an issue in securing new, safe housing options, continues to be the FMR requirements. Landlords are increasing rent at a much higher, and faster rate than ever before, where we have not been to secure units, or have even lost units from years past, and the rent continues to increase with the demand.

The Jefferson County Transitional Housing Program (THP) is operated by Community Action Coalition for South-Central Wisconsin (CAC). CAC will use CoC funding to provide 10 homeless households with housing for up to 24 months using the Housing First model, including case management. Participants selected must meet the HUD definition of homelessness and fall under category 1, 2, or 4, as well as be on the Jefferson County Prioritization list. Scattered site apartments in Jefferson and rural Waukesha counties are provided to participants but leased by CAC. This program is goal-based and involves intensive case management and supportive services, including referrals to other service providers if necessary. Although supportive services are voluntary, they are strongly encouraged. Program success is measured by CAC's ability to help participants move into stable and permanent housing upon exit of program. Approximately 80% of THP participants enter permanent housing upon exit currently. Participants often enter the THP program by first receiving a motel voucher because of the lack of emergency shelters in the area or are forced to live in an uninhabitable space. Caseworkers work with participants to overcome barriers they may face to being self-sufficient. Caseworkers provide supportive services and limited financial assistance for the following supportive services: AODA counseling, transportation, childcare, medical co-payments, dental assistance, and grocery vouchers. All program resources are carefully tracked by caseworkers through a central customer management program called Salesforce. Participants are encouraged to attend monthly educational group meetings, acquire a savings account, maintain renters' insurance, and participate in weekly household visits with caseworkers. All participants are screened and referred to the appropriate agencies through the Coordinated Entry process at CAC. The THP program is set up to help participants achieve the best outcomes by providing financial assistance as well as supportive services. CAC is an active member of the WI Balance of State Continuum of Care, the Housing Action Coalition in Waukesha County, and the Dane County Homeless Services Consortium.
