### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This PSH Program will provide permanent housing, intensive case management and supportive services to single adults (75%) and families (25%) who have a disability and are currently experiencing chronic homelessness as defined by HUD and prioritized using the Balance of State prioritization list for singles and families and the non-HMIS list. Utilizing a housing first philosophy, CAI proposes to continue offering 12 scattered site rental units between Rock and Walworth Counties. The objective of our PSH program will be to provide community based housing without a designated length of stay for those with a disability experiencing chronic homelessness. As opening/s become available those prioritized will be contacted to update homeless status. If the household is still in need of housing they will be offered the program and scheduled to meet with a case manager to confirm chronic homelessness and disability. In addition participants will be guided through the enrollment process that includes finding a housing unit that is appropriate for household size and meets fair market rent and rent reasonableness standards. Each individual/household enrolled will have 30 days to locate a unit that meets required standards. If a unit is not secured in this time frame, an extension can be given. Once a unit has been identified, landlord is in agreement with program requirements and unit passes a Housing Quality Standards Inspection the participant may proceed with a lease signing in coordination with Community Action as the primary lease holder. The program will pay security deposit and up to 100% of the participants monthly rent as determined by the household's adjusted gross monthly income. Case management services will be offered to the participant on a regular and consistent basis as determined by the individual's service plan. Case management may include but is not limited to assessing, planning, coordinating, implementing and evaluating the overall services delivered; connecting with mainstream resources; and support in learning to live in housing independently, maintaining their housing, being a good neighbor and tenant and assisting in the creation of support systems within the community should they choose. Each individual's service plan will be client centered and acceptance of the services offered is not a condition for continued housing assistance. CoC funding is needed to allow us the ability to serve the chronic homeless population in our communities as we work to reach the HUD and CoC goal of eliminating homelessness. At this time, 24 chronic homeless individuals/households have been identified on the Rock/Walworth prioritization list, 22 singles and 2 families. There has been a significant decline in the number of chronically homeless families on the prioritization lists, 2 PSH families exited and 1 PSH family became a single household when an adult child moved out thus the change in percentage of individuals vs. families we anticipate to serve. Funding will be used to provide long-term rental assistance, case management and other needed supportive services on an individual basis to stabilize housing for PSH participants. Program Outcome goals include: 90% of participants exit the program to permanent housing, 20% increase earned income and 35% increase other income. Due to the permanent nature of this program we do not anticipate many exits during this contract year.
