The CAI RRH Program will provide up to 24 months of rental assistance, case management & supportive services to single adults and families who are currently Category 1 or 4 homelessness as defined by HUD and prioritized using the BoS prioritization list for singles and families and the non-HMIS list. Utilizing a housing first philosophy, CAI proposes offering 20 scattered site rental units in Rock County and 10 in Walworth County, but the tenant makes the decision of where they choose to live. The objective of our RRH program will be to exit homeless individuals and families into sustainable permanent housing as quickly as possible. CAI will utilize the BoS CE Prioritization system when enrolling into its RRH Program. No one will be denied or screened out of services because of evictions, poor rental history, credit, or criminal background. As openings become available, those prioritized will be contacted to update homeless status. If still literally homeless and/or fleeing domestic violence they will be offered RRH, scheduled to meet with a case manager to verify and confirm homeless eligibility and guided through the enrollment process that includes finding a housing unit that is appropriate or household size and meets fair market rent and/or rent reasonableness standards. Each individual/household enrolled will have 30 days to locate a unit that meets required standards. If a unit is not secured in this time frame, an extension can be given. Once a unit has been identified, landlord agrees with program requirements and unit passes the HQS Inspection the participant may proceed with a lease signing directly with the landlord. The program will pay security deposit & up to 100% of the participants monthly rent as determined by the household's adjusted gross monthly income. At a minimum, case management services will be offered on a biweekly basis & client centered housing stabilization plan will be established. Additional supportive services offered may include, but not limited to; education services, employment assistance, life skills, food, transportation & child care. Every effort will be made to provide each participating household with the information, resources & access to mainstream benefits that may be available to them. CAI coordinates with other agencies in our service area such as ECHO, Food Pantries, School Liaisons, employment services, county human services departments & healthcare service providers. We complete a mainstream resources form and refer to any agency that may be able to provide assistance. Examples: ECHO-has a RRH program, work together when pulling for

openings, make referral to their food panty. Healthcare- Compass's project connect, Rock County CCS, My Choice, and HealthNet-refer for services. Rock County CCS-joint home visits, coordination of mental health services. School Liaisons-they refer homeless to us, we refer households to them for transportation assistance. Human services-CPS-support team meetings. Take people to job center to work on resume and look for jobs.

Outcome goals include: 75% of participants exit the program to permanent housing, 30% increase earned income & 35% increase other income. CoC funding is necessary for CAI to serve the homeless population in our communities as we work to reach the HUD & CoC goal of eliminating homelessness.

Funds will provide medium-term rental assistance, case management & needed supportive services on an individualized basis to stabilize housing.
