### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

Couleecap's New Hope Permanent Housing Program provides 19 units of permanent supportive housing in a four county area in Western Wisconsin. A majority of the units are located in La Crosse, WI where the need is higher. The housing first model is utilized in the delivery of services to households who are literally homeless, and places a priority on serving those who are chronically homeless. A majority of program participants are also living with drug and alcohol issues, have zero income, poor rental histories, criminal backgrounds. 100% of program participants come from the streets or emergency shelter. Couleecap participates in the coordinated entry process, VI-SPDAT, and uses the approved WIBOSCOC standards and prioritization policies when enrolling participants into the program. Couleecap utilizes a low barrier approach to program entry and quickly moves participants into permanent housing. Couleecap has established strong working relationships with local landlords that allows us to secure appropriate housing in an efficient manner. Program participants are encouraged to develop goals and meet outcomes in improving housing stability, increasing income, and increasing access to mainstream benefits. We attempt to reach 85% of the participants staying in PH for at least six months, and have 40% of participants increase their overall income, while encouraging at least 90% of participants to enroll in mainstream resources. Case managers focus on assisting program participants in developing self-sufficiency while getting connected to mainstream resources. Program participants are supported and encouraged to get connected with mental health resources and to stabilize and treat their mental health. In addition, staff are able to connect participants with Social Security benefits utilizing the SOAR Program offered through Couleecap. Couleecap partners with area agencies who can provide services to program participants. Couleecap actively makes referrals to these agencies and maintains excellent working relationships with such agencies. Examples of partnerships include but is not limited to: county human services departments, local agencies who address drug and alcohol addiction, hospitals and clinics, local emergency shelters, mental health providers, transportation providers, food pantries, etc. COC funding provides the foundation of funding for this program, and local match and leverage is secured to supplement the funds. Without COC funds, this program could not be offered in the community. Couleecap's New Hope Program has budget categories of supportive services, operations, leasing, and administration. Couleecap utilizes Wisconsin Service Point at its HMIS data base.
