### CORE TEAM for Sprint

We felt that in the spirit of the donations for innovative solutions, we would like to see the money go to a PR campaign in the Dairyland Coalition and start a prevention/diversion program in the community. # **Erin Healy Report Debrief -**

- 100 day sprint with goal to house 16 chronically homeless individuals. 13 were housed and it increased the housing rate 282%.
- Landlord recruitment and involvement made progress through new relationships. They created a landlord support program which includes a landlord risk mitigation fund. The fund has a process of how to access it and the city has provided \$14,000 to the fund. Rent Readiness curriculum was also created. Scott Allen (City Planner) needs to review the trainer's contract and then it will be given to John Derousa (trainer) to use the curriculum.
- There was great progress in our partnerships and collaboration with community members.
- The Community Table, Catholic Charities (Brianne Berres) and Lutheran Social Services are
  working with Tom Wirth to create a community center that houses all three organizations.
  They are looking for more buy-in from other local agencies that want to be housed either on
  certain days or permanently in the community center. Wondering if it's possible to have
  someone to focus on this as their job instead of one agency trying to spearhead the work.
- Affordable housing progress has been made: the city council has approved to vote to create
  an ordinance for a Housing Opportunities commission with 11 members. This will be voted on
  at the January 27<sup>th</sup> meeting. JONAH's Affordable Housing committee is working with
  developers to create specific housing for low-income community members.

# **Agency Updates**

### Jeanne Semb: Western Dairyland

• We have the Permanently Supportive Housing program and serve our most "needy" community members from the Coordinated Entry list, but are finding that the supports these community members need are far beyond the PSH programming. Clients currently have substantial mental health concerns and substance use. There is a gap in services in our community that can meet the needs of someone that cannot competently care for themselves without putting themselves at risk without 24-hour supervision. ADRC has a long-term care voluntary program: Waiver services (for individuals with developmental and physical disabilities) and medical assistance may cover some services. Peer support could be an option to work with clients and help relate to them. Positives Avenues has a peer-support

program and Kelly Green has been trained. EXPO and Sarah Ferber would also have peer support info.

- Question: Would the peer support person work on living skills?
- It would be helpful if agencies can collaborate to provide soft hand-offs to other agencies and build trust with the client for them to work with the next agency's staff members.
- Question: If a person was not homeless but having issues as these clients do, what would the
  next step be? Become homeless for the first time? Determined by a therapist to be unable to
  care for themselves. Make a human services report? Will DHS look at the "homelessness"
  factor and assume our homeless system will take care of them? Could a occupational
  therapist evaluate them and be able to determine the client's competencies?
