- Plan of Action Defined in 1/18/18 Meeting
 - ✓ Gather/compile all notes for committee review
 - Consensus is all 4 areas view releasing to shelter as not releasing to homelessness
 - ✓ Review compiled notes to bump up against existing policy
 - Existing polices state need for discharge planning, but don't specifically address releasing to shelters
 - ✓ Analyze 4 areas amongst group to assess gaps and best practices identified
 - Unsure of our ability to impact policies beyond providing best practice, especially when the person is already at a shelter and goes into a hospital or treatment facility of some type
 - Waukesha will tell hospital at admission that a patient cannot come back to shelter if they are unable to physically care for themselves with the expectation hospital discharges to a rehab/nursing facility
 - Fox Valley hospitals often call the shelter prior to discharge to confirm it is an option
 - Limited information has been gathered on youth coming out of Foster Care
 - Outagamie county is developing a release from jail program that will be shared once we have the info
 - Document best practices from analysis
 - Define process to meet with institutions to discuss best practices
