

Local Coalition/Emergency Partners Meeting February 27, 2018

Meeting was called to order. Mae Nachman taking minutes.

M. Randall:

- Governance Options
 - Group went through all three options of governance structures.
 - Discussed Pros/Cons of each within our local coalition
 - Discussion that option 1 did not provide representation for all the coalitions
 - Is simple and concise
 - Discussed Option 2-
 - many felt this was more representative of local coalitions
 - have the capacity to support this
 - Discussed option 3-
 - much more representative
 - do not have the capacity to support this option
 - Discussed pros/cons document sent by BOS for each governance option
 - Discussed the town hall meeting comments from the BOS meeting in Eau Claire
 - Discussed the comparison of Board structure within other CoC's
 - Opened up to any further discussions – none needed
- Call to Vote on Options for Governance in person
 - Option 1 – NO VOTES
 - Option 2- All in favor
 - Option 3- NO VOTES
 - **OPTION 2 is the choice for this coalition**
 - Discussed other bylaw changes
 - Called to vote on remaining changes in person
 - VOTE: All in favor of remaining changes to bylaws
- Adult Drug Treatment Court Presentation
 - Alternative to revocation for high risk/high need adults with substance abuse

- Cannot have a violent offense
- Have a treatment team consisting of Judge, Prosecutor, probation and parole, law enforcement, AODA provider and Drug Court Coordinator
- Regular appearance before the tem on a docket; twice a month min
- Consequences and incentives are provided
- There are phases for the treatment court
- Max of 20 participants; currently 13 in this court
- Have a 5 year funding
- Have an agreement with Salvation Army because participants need a known location in order to be in this treatment
- 90% of participants have a meth addiction
- They expect relapse during this treatment; they don't feel you can help an addict by throwing them in jail
- 30-40 hours of treatment a week plus NA or AA (it's very intensive)
- Designed to last 14 months/costs \$750 and \$250 can be worked off with community service
- Will have first graduate in mid-July

Partner Updates and Agency Discussion:

- Mae- United Way
 - Discussed the program "In a Fix" that will be offered through Emergency Services through United Way to assist with up to \$500 in car repair for eligible participants
 - Phase 33 and 34 is closed
- Mike Clements-Veteran Liaison
 - Discussed initiative backed by VFW to look into a veteran's court
 - Discussed mental health/AODA issues once back from war
- William – CVI
 - Discussed the funding he has for veterans with a honorable discharge
 - Mentor with drug treatment court
- Jennifer-Salvation Army
 - Pastor Tom is the new director at Salvation Army
 - There will be a lot of changes and they are in an unknown zone currently
 - Salvation Army is at capacity
 - Seeing a lot of single men and single female numbers rising
 - Discussed their agreement with probation and parole for those participating in drug court and are not exiting them from the shelter due to a relapse like they previously did
 - Food donations are down and roundy's donations has ended for all food programs

- The shelter may be expanding
- ECI
 - Closed their food pantry due to not receiving enough food
 - The majority who received food from them did receive food from other pantries.
 - They have moved toward more the emergency food pantry and it's only on a case by case basis with no specific hours
 - Kids Closet is still busy as ever providing clothing to children
 - They have 60-80 people for the free meal show up on Thursday nights on average
 - Schools are currently collecting hygiene items to help the children who are homeless and these will be served by the schools- 88.5 is helping with this and it is posted on the "helping hands" facebook page
 - Warming shelter has been busy- 7.8 average last season and at 8.5 average per night this season
 - Many folks with mental health and AODA issues; trend is more people with criminal issues and a lot more police drop offs- they have between 20-30 police drop offs
 - They have served 46 people this season so far; whereas the total number last year was 47
 - They have seen some permanent housing success
 - Struggling with volunteers and are also looking to hire someone who has some knowledge with mental health
- Emergency Services
 - New staff hired
 - Numbers of folks needing assistance seems to be up average any where between 30-90 people a day
- Energy Services- Lori
 - Service requests are down for all counties but have seen new people applying
 - Increase in propane assistance
 - Disconnection notices will be going out in a couple of weeks and they will be trying to get them on payment plans
- United Way 211
 - Has database for people seeking assistance to do their own searches for resources
 - Top two request for needs are free tax program and rent assistance
- Operation Bootstrap
 - Will only provide rent assistance once per year – more so in the form of the security deposit- limited other emergency rent- they did increase the budget for the assistance-will only assist with up to \$700 max

- Have new volunteers
- Appears to have more requests for food deliveries rather than pick ups
- Food donations are slightly up
- 700 coats were given out this year
- Redeemer – Valerie
 - Have breakfast for the homeless on Saturday morning with average of 15-20 people being served
 - Assisted a couple in getting back to TX and they are open to assisting people in transportation such as this
 - Continue to have a mobile pantry
 - Roundy's no longer provides food for any pantry
- St. Vinnies- Sherry
 - Seeing more families and more middle age adult singles
 - Two times a month they hold the pantry
 - Have been using feeding America but see more costs for this
 - Increase in serving men getting out of prison without anything
 - Also provide free coats and free clothing and housewares
- Interfaith food pantry
 - 10% increase from 2016
 - Average family uses the pantry about 6.5 times a year which is an increase from 5.3 the previous year
 - Seniors are coming more often
 - Changed the structure a bit it is now open 5-8
 - Would like to see a more coordinated approach to the food pantry systems here
 - Discussion ensued about joining the hunger coalition and view what other communities are doing
- Boys n Girls Club- Jeremy
 - Plover location has been remodeled and is huge
 - 300 kids a day at the Berard Center – they are looking to distribute kids out more evenly
 - Gateway program- working with delinquent children who are ordered to attend- music and art therapy is part of this group
 - Free meals daily after school and will continue free lunch in the summer
