Discussion about "Eviction" Decision to meet in Feb. from 2:30-3:30 to discuss book. 3:30-4 will be agency sharing. Liz will bring discussion questions. Do not to have read book to discuss but would be good. 2:30 start time is for those who can come early. Kathy Thunes will change her presentation to June so we can have the entire hour to talk about the book.

Program: Liz Groeschl and Kristina Ebbott form "Legal Action"

Serves low income. BIGGEST issue: people don't contact LA soon enough to get help they really need. All clients are screened-income must be 200% of the poverty level. There is an asset limit. Lawyers always check first for "conflict"-If an individual has been there before their partner, etc. would not be served. Those folks would be referred to the State of Wi referral service.

#### Legal Action Programs:

- 1. Can handle-housing-private/public eviction, rental termination, denied access, lockouts and writs of restitution.
  - a. Under "severe conditions" will help break leases.
- 2. Foreclosures-can explain/advise. Can help tenants if landlord is in foreclosure.
- 3. Family Law-physical domestic violence, divorce, custody changes, and placements. May also send to volunteer attorneys.
- 4. Public Benefits-help with termination of benefits, denial, overpayments, food share, social security, Medical Assistance, unemployment compensation.
- 5. Consumer Law-Bankruptcy cases are usually going to volunteer attorney program. Lots of advice is available.
- 6. Debt Collection-check to see if garnishment/collection procedures follow the law.
- 7. Utility Disconnect-help when service threatened to be cut off or inability to pay.

- 8. Credit/ID theft/loan/car titles issues
- 9. Driver Licensing Recovery program-help get license back, payment schedules for tickets so license can be retrieved etc.
- 10. Does not do education law or criminal law.

Things to remember: LA does not take all cases. Depends on current case load and severity of specific cases. They do refer to volunteer attorneys and individuals can also be referred to private attorneys. Often there is no fee. Additionally, there is a "Modest Means" program through the State of Wi Bar. No referral from necessary.

Legal Action always gets back to prospective clients in 5 days, but most often it is sooner.

Kristina Ebbott-New Program-Elder Rights Project. New to our area. People can self-report, must be 60 or older, be a WI resident and have a civil legal need related to victimization.

There is a hotline, no asset limit or income restriction.

Both Liz and Kristina emphasized the importance of calling LA with the issue. You will never know if they can help unless they hear what the case is about. Some areas are busier than others but LA always tries to at the very least give advice or referrals

Legal Action of Wisconsin, Inc., in Oshkosh, is now offering two new programs in all of the counties we serve: the Driver's License Recovery Program and the Elder Right's Project. Please find attached two flyers, one about the Driver's License Recovery Program, and another about the Elder Right's Project.

Also, two side notes from the meeting the other day: regarding car titles, our office is accepting cases for advice and possible representation regarding many problems with car title problems, including questions about repossession or loans. Regarding driver's license recovery, we are accepting cases for advice and possible representation involving safety responsibility fines resulting in driver's license suspension. When in doubt, refer the person to our office, or give us a call at (920) 233-6521.

Presented on the new Elder Rights Project at Legal Action of Wisconsin. We are taking referrals for potential clients who are: (1) Wisconsin residents; (2) Age 60+; (3) Victims of crime or abuse; and (4) Have civil legal needs related to the alleged abuse. There are no income or asset requirements for eligibility, and the crime or abuse does not have to be reported to police or referred to an investigative entity. ### **Driver's License Recovery**



Driver's license suspensions and revocations are a barrier to employment to many people in our community. Many jobs require a driver's license, and often, many workers commute long distances to their jobs. Legal Action of Wisconsin, Inc., aims to provide legal assistance to individuals who have active suspensions and/or revocations against their Wisconsin driver's licenses or against their ability to obtain a Wisconsin driver's license.

#### **ELIGIBILITY CRITERIA**

- Meet Legal Action of Wisconsin, Inc.'s eligibility criteria
- Have a suspended or revoked Wisconsin Class D driver's license, or suspended or revoked privilege to obtain a Wisconsin Class D driver's license
- Be within the Office's service area and at least 18 years old
- Be under 200% of the federal poverty level
- Have no pending charge for Operating While Intoxicated (OWI) and no current revocation for OWI
- Have completed DMV written/knowledge test within past 12 months if the person hasn't had a valid driver's license in the past 8 years

Some examples of suspensions and revocations that Legal Action of Wisconsin, Inc., in Oshkosh, may assist with include but are not limited to the following:

- Failure to Pay a Forfeiture
- Demerit Points
- Operating While Suspended/Revoked

NOTE: In addition to the eligibility criteria listed above, many factors are considered to determine whether a case will be accepted for representation. These factors include but may not be limited to whether or not there is a legal conflict, staff availability and resources, and legal merit.
