Kellie Arndt-Solutions Center The women's shelter is at full capacity. At the women's shelter, we recently started making one of the offices into a usable library for our clients to use for a quiet space and as a place to research jobs and housing.

Amber Rose-Salvation Army The Warming Shelter information, I'll attach the flyer I shared. The warming shelter has 46 cots if those cots fill up we will not turn anyone away. They can sit at the tables in our fellowship hall to at least get out of the cold.

Linda Tack-FdL School District There are currently 101 children identified as homeless in the public school district. Most are doubled up and the search for rental units is the most pressing concern for these families.

The Balance of State is devised of 69 counties. These agencies collaborate to obtain funding to serve individuals and families experiencing homelessness and work side by side to provide support. The Balance of State also works with HUD and other members within the state on policies, procedures, standards, trainings and data.

What is the Youth Advisory Board This group of diverse, young and vibrant youth will come to the table to discuss the services being offered throughout the Balance of State, as well as offer insight from a youth's perspective. This group of participants will also look at policies and procedures across the state and offer feedback to not only the Balance of State but also to HUD. This will also include choosing providers for new programming in many areas within the state of Wisconsin. The ultimate goal is to End Youth Homelessness and this group will be tasked with that commitment.







Provides practical information to help people find and keep a decent place to live. Rent Smart emphasizes skills that may help tenants avoid legal confrontations. It stresses both tenant and landlord responsibilities and the advantages gained from viewing the landlord-tenant relationship as mutually beneficial rather than confrontational.

The Rent Smart Curriculum was developed by staff from the University of Wisconsin-Extension in consultation with the Wisconsin Apartment Association, yhe Wisconsin Trade and Consumer Protection Division, the Tenant Resource Center, the Apartment Association of Southeast Wisconsin, and other housing and tenant support groups.
