**4a. If HUD recaptured funds provide an explanation.**

The main cause of funds being recaptured was due to low unit utilization. In 2022, the Permanent Housing Connections Project bed and unit utilization occupancy was not at full capacity during the grant period due to the following circumstances.

Thirty-two percent or eight participants were assessed to be move on-ready and transitioned to Emergency Housing (EH) Vouchers during the grant year. As a result, we experienced a loss of long-term partnerships with landlords because people transitioning to EH Vouchers remained in those units. Therefore, the process of enrolling eight new people into the program took a significant amount of time because of the following:

1. Overall, there were not many individuals on the Permanent Supportive Housing Coordinated Entry (CE) Chronic Prioritization list. This grant year there was a significant amount of time spent on chronic homeless tracking to help increase the number of individuals eligible for the program.
2. Known individuals who are experiencing chronic homelessness in the community refused to participate in CE and services.
3. Individuals that were on and pulled from the Prioritization list did not meet the chronic homeless criteria for program eligibility.
4. Individuals pulled from the Coordinated Entry Prioritization list from other communities were unwilling to relocate to Kenosha.
5. Several eligible individuals pulled from Coordinated Entry were difficult to locate due to incarceration and pending criminal charges.
6. The new Landlords that the program was able to identify had requirements that created significant barriers to leasing up which resulted in a significantly longer length of time between program enrollment and move in date.

Overall, sixty-nine percent, or thirteen participants exited the program to permanent housing during this grant period.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The project will serve 25 single individuals in scattered site units of their choice. The target populations to be served are single adults who meet the HUD definition of chronic homelessness and are living with disability. 70% of participants will come directly from shelters and 30% from the streets or other places not meant for human habitation. The project will use a Housing First approach as evidenced by having no barriers to program entry, programming that is not contingent on participation in services and rehousing participants in the event of an eviction while in the program. To address housing needs, we will maintain our established relationships with landlords to ensure that units are available. The leasing budgets will be monitored monthly to ensure timely spend down of funds. Funding will be used to lease 25 units of scattered-site apartments with 25 bedrooms at any point in time and supportive services that includes 2 FTE case managers focused on teaching needed skills to stabilize housing and income, .25 FTE supervision, .5 FTE moving assistance, food, transportation and operations. Other direct services that address the identified needs of the target populations served are housing search/counseling, life skills training, mental health services, outreach services, and substance abuse treatment. Non-partner agencies provide childcare, education services, employment assistance/job training, legal aid, outpatient health services and utility deposits. The program estimates that 80% of participants exiting the program will remain in or exit to permanent housing, 54% percent of participants will maintain or increase total income, 20% of participants will maintain or increase earned income, and 90% of people will access mainstream resources while on the program which is consistent with the original grant. Our Local CoC has met since 1986 as a community effort to coordinate services, share information, attract funding and eliminate duplication/service gaps for low-income people. There are 35 entities represented. Our agency is an active member of the local CoC and chairs the CoC Coordinated Entry System that meets monthly to review program capacity, referrals, system functioning and improvements. For our 20 years of project operation, we have learned to rely on our robust social service delivery system. HUD CoC support is a vital extension to our system that strengthens the work we do to end homelessness.


As a match to Kenosha Permanent Housing Connections- WI0175L5I002207 the Kenosha County Department of Human Services, Division of Aging and Disability Services under contract with Kenosha Human Development Services, Inc. commits the following mental health services: Crisis Intervention, the Community Support Program, Crisis Case Management, KARE Center, and the Court Liaison Program. The Kenosha County Department of Human Services, Division of Children and Family Services under contract with Professional Services Group and KHDS commits mental health services through Comprehensive Community Services. Services are based on an average rate of \$59.64 per hour and the KARE Center is based on an average rate of \$77.26 per hour. The value of the services is estimated at \$28,000 not to exceed \$40,000 for the year.

The mental health services will be available beginning January 1, 2025 through December 31, 2025. The mental health services will be provided to eligible participants of the HUD CoC program on an as needed basis and hours of services will be documented in order to fulfill recordkeeping requirements of the CoC Program.


