The KYF Rapid Rehousing Project provides supportive services and rental assistance to 10 individuals at maximum capacity for up to 24 months. The target populations served are adults living with severe mental illness and chronic substance use. 90% of participants come directly from shelters and 10% from the streets or other places not meant for human habitation. The project uses a Housing First approach as evidenced by having no barriers to program entry, programming that is not contingent on participation in services and rehousing participants in the event of an eviction while in the program. To address housing needs, we maintain our established relationships with landlords to ensure that units are available. The rental assistance budget is monitored monthly to ensure timely spend down of funds. Funding will be used to lease 10 units of scattered-site apartments with 10 bedrooms at any point in time and supportive services that includes 1 FTE case manager focused on teaching needed skills to stabilize housing and income, .17 FTE direct assessment of needs,.29 FTE moving assistance, food, and transportation. Supportive service needs are individualized and addressed by teaching needed skills to stabilize housing and income and providing supportive services that includes direct assessment of service needs, moving assistance, case management, food and transportation. Other direct services that address the identified needs of the target populations served are housing search/counseling, life skills training, mental health services, outreach services, and substance abuse treatment. Partner/non-partner agencies provide child care, education services, employment assistance/job training, legal aid ,outpatient health services and utility deposits. The program projects that eighty percent of participants exiting the program will achieve housing stability, twenty percent of participants will increase earned income, twenty percent of participants will have employment at exit and ninety percent of people will access mainstream resources while on the program. Our Local CoC has met since 1986 as a community effort to coordinate services, share information, attract funding and eliminate duplication/service gaps for low-income people. There are 35 entities represented. Our agency chairs the local CoC Coordinated Assessment System that meets monthly to review program capacity, referrals, system functioning and improvements. HUD CoC support makes the work we do to end homelessness possible by providing funding for comprehensive services and also holds us accountable to the HEARTH Act.



The value of the services is dependent on the services used by program participants and is estimated at \$12,000, not to exceed \$30,000 for the year.

The mental health services will be available beginning July 1, 2022 through June 30, 2023. The mental health services will be provided to eligible participants of the HUD CoC program on an as needed basis and hours of services will be documented in order to fulfill recordkeeping requirements of the CoC Program.


