3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The project will serve 25 single individuals in scattered site units of their choice. The target populations to be served are single adults who meet the HUD definition of chronic homelessness and are living with disability. 70% of participants will come directly from shelters and 30% from the streets or other places not meant for human habitation. The project will use a Housing First approach as evidenced by having no barriers to program entry, programming that is not contingent on participation in services and termination from the program that is limited to severe lease violations. To address housing needs, we will maintain our established relationships with landlords to ensure that units are available. The leasing budgets will be monitored monthly to ensure timely spend down of funds. The project will lease 25 total units of scattered-site apartments with 25 bedrooms at any point in time. Identified supportive service needs will be addressed by 2 FTE case managers focused on teaching needed skills to stabilize housing and income and providing supportive services that includes direct assessment of needs, moving assistance, case management, food and transportation. Other direct services that address the identified needs of the target populations served are housing search/counseling, life skills training, mental health services, outreach services, and substance abuse treatment. Non-partner agencies provide childcare, education services, employment assistance/job training, legal aid, outpatient health services and utility deposits. The program estimates that 80% of participants exiting the program will remain in or exit to permanent housing, 54% percent of participants will maintain or increase total income, 20% of participants will maintain or increase earned income, and 90% of people will access mainstream resources while on the program which is consistent with the original grant. Our Local CoC has met since 1986 as a community effort to coordinate services, share information, attract funding and eliminate duplication/service gaps for low-income people. There are 28 entities represented. Our agency is an active member of the local CoC and chairs the CoC Coordinated Entry System that meets monthly to review program capacity, referrals, system functioning and improvements. For our 20 years of project operation, we have learned to rely on our robust social service delivery system. HUD CoC support is a vital extension to our system that strengthens the work we do to end homelessness.
