### Interagency Council on Homelessness Mission and Responsibilities

- "The council shall meet quarterly and may meet at other times on the call of the chairperson or a majority of its members."
- "Establish and periodically review a statewide policy with the purpose of preventing and ending homelessness in this state."
- "Designate individuals from each agency or organization represented on the council, who shall meet at least twice quarterly, to coordinate the implementation of policy established by the council."
- "Submit a report on the activities of the council to the governor and to the chief clerk of each house of the legislature, for distribution to the appropriate standing committees."

#### 2023 State Activities

- WHEDA awarded Housing Tax Credits to projects throughout Wisconsin in May. These projects will add over 1,500 units for low-income households – including projects in Sauk, Waupaca, La Crosse, St. Croix, Vernon, Manitowoc, Crawford, and Marathon Counties
- WHEDA opened the 2023 Housing Grant Program competition. This program, to assist in the improvement of the state's housing for special needs populations, will award \$2 Million to projects. Reminder, the deadline for applications for this program is 11:59PM TONIGHT.

#### 2023 State Activities

- The State Legislature passed, and Governor Evers signed, Acts 15, 17, and 18. These laws, and funds provided through the 2023-25 budget, will provide \$550 Million in one-time funds for housing rehabilitation and commercial-toresidential conversion to add workforce housing units.
- The Recovery Voucher Grant Program, funded with \$2 Million from the State's opioid settlement, launched in 2023. Through this program, housing vouchers for recovery housing will be provided to people experiencing homelessness who have an opioid use disorder diagnosis.


#### 2023 State Activities

- The Children's Health Insurance Program Health Services Initiative (CHIP HSI) launched on May 1. Through this program, five agencies in the BoS area (CW Solutions, Family Promise of Washington County, House of Hope Green Bay, Renewal Unlimited, and Shalom Center of Interfaith Network) will be able to provide housing support services for households with dependent children or persons who are pregnant who are experiencing homelessness.
- Department of Veterans Affairs: The Veteran Outreach and Recovery Program has been adding staff – changing the structure from 11 regions to 16 regions and adding 2 clinicians to better expedite services for veterans experiencing homelessness or housing instability.




- Organize and/or facilitate activities (meetings and workgroup sessions) for the Council,





## Coming up

- Department of Health Services is projecting the 1915i State Plan Amendment to be finally approved by the federal government during the next couple months. This will provide housing support services through Medicaid for people experiencing homelessness who have substance use disorder and/or mental health disorder diagnoses.
- Department of Administration is projecting the HOME-ARP program will begin within the next three months. Nearly \$42 Million will be provided to develop affordable rental housing, tenant-based rental assistance, and supportive services.

## Coming up

• Progress will continue on items in the "Welcoming Wisconsin Home" statewide plan on homelessness. This includes the start of applying the racial equity analysis tool to analyze state programming outcomes.
