North Central CAP's Housing First Program provides 10 units of permanent supportive housing in our service area, with majority located in Marathon County, WI. The housing first model is utilized in the delivery of services to singles who are chronically homeless. A prioritization is put on serving chronically homeless. The majority of program participants will have drug and alcohol issues, criminal backgrounds, poor rental history, and no income. 100% of the program participants come from emergency shelter or directly from the streets. North Central CAP utilized the Coordinated Entry process, VI-SPDAT, and uses the approved WIBOSCOC standards and prioritization policies when enrolling participants. NCCAP uses a low-barrier approach to program entry so participants are quickly moved in permanent housing. NCCAP has a long established working relationship with local landlords allowing us to secure housing in a relatively short time span. Participants are encouraged to develop goals to meet outcomes in improving housing stability. We attempt to reach 75% of the participants staying in PH for 8 months, with 50% of the participants increasing overall health and overall income. We hope to encourage 90% of participants to enroll in mainstream benefits while our case managers focus on supporting the participants in this process. Our staff also offer our participants transportation to and from mental health and AODA counseling, provide life-skill coaching, budgeting, Skills enhancement training and connection to our partners in the community such as food pantries, DVR, the Job Center, and a few employers known to work with individuals with AODA issues, hospitals and clinics, day centers to improve social skills and provide social interaction, local county health and human services dept. etc. The demand for this type of housing and supportive services is high in our community. This grant will pay leasing costs for 10 units, provide for payment of utilities for units where utilities are not included with rent, provide extensive case management (supportive services), transportation costs for participants (cab rides and/or bus passes), AODA assessments, Life skills training, educational services, enrollment fees for on the job training, proper clothing for jobs obtained, assistance with moving costs if necessary, and administrative costs associated with this grant. Without COC funding, North Central CAP would not be able to offer this program.



Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
