1. Describe your organization’s (and subrecipient(s) if applicable) experience in effectively utilizing Federal funds and performing the activities proposed in the application.

North Central Community Action Program, Inc. (NCCAP) is a private, not-for-profit, IRS designated 501(c)3, in continuous operation since 1966. The Agency has several revenue streams including federal, state, local and private grant funds and donations. We’ve always spent down all of our grants and utilized the monies as specified in the grants. In 2019 NCCAP implemented its first permanent supportive housing (PSH) program. This program was developed under CoC funding and addressed the community’s growing problem with chronic homelessness. The agency applied for and received funding to lease 10 PSH units, thereby taking half of the homeless population at the time, off the streets into programming to help them succeed at addressing many of the issues causing them to be homeless. NCCAP has extensive experience in the homeless prevention/housing program area and our community partners rely on our agency to assist with housing the chronically homeless population. We have a good relationship with the County and City government officials and their staff. We have City and County board members from Wood, Marathon, and Lincoln Counties. NCCAP is well respected and is recognized as an Agency who provides low-income individuals and families an opportunity to become self-sufficient.

NCCAP has operated a HUD-funded COC project for 25 years. First we ran a transitional housing program, then re-allocated to a permanent supportive housing program. NCCAP has secured match funds to administer this program and we have managed the program within our organizational structure including our finance department. NCCAP has worked with the North Central COC in establishing a service delivery system. NCCAP is the lead agency in the local continuum and works closely with numerous organizations including emergency shelters, dv agencies and others in north central Wisconsin. Our local COC is made up of many community partners who provide housing, housing assistance, shelter, and many other partners who can provide necessary services to our clients, such as counseling, food and basic need items, mentorship, AODA services, child care services, etc.

2. Describe your organization’s (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

North Central Community Action Program has provided assistance to individuals and families experiencing homelessness for 35 years utilizing federal, state, and private grant funds. We have an established track record of effectively and ethically managing these funds. The agency adheres to the rules and expectations specified by grantors as well as the WI BOSCO. We have demonstrated a commitment to best practices and determining how to provide and deliver services that match the needs of people experiencing homelessness. In addition, NCCAP has administered TEFAP, TBRA, EHH, HCRI, THP, PSH, and Housing Choice Voucher funds. NCCAP receives funding from four United Ways, three private foundations, and two County governments. We work with our community partners and private funders to provide cash match and in-kind match. These are documented in the general ledger and tracked by our finance department.

3. Describe your organization’s (and subrecipient(s) if applicable) financial management structure.

Accounting department structure includes Director of Administration, accounts payable/payroll clerk, and accounting/finance assistant. Director of Administration reports to the NCCAP board at bi-monthly meetings. The Board’s finance committee reviews financial monthly statements and other pertinent information. The Board chair meets with the auditor on an annual basis to discuss agency performance and review the 990. The accounting firm presents the agency audit to the full board on an annual basis.

NCCAP uses Abila MIP Fund Accounting software. The chart of accounts consists of five segments; Grant Fund, General Ledger (departments and accounts), Balancing, Non-Balancing, and Restriction. We maintain segregated records (by grant fund) and generate reports on a regular basis for our funders. Finance maintains accounts and documents needed to identify the source and application of funds for grant activities. This assists in producing reports for our funders. Accounting staff duties (recordings of transactions, physical control of items, maintenance of general ledger accounts, and payroll) are segregated. NCCAP utilizes an internal control segregation of duties grid to ensure separation of duties.

An independent certified public accounting firm, Wipfli, conducts yearly audits in accordance with provisions of OMB Uniform Guidance 2 CFR part 200. North Central CAP certifies that the agency maintains an established organizational structure, financial policies/procedure and an internal financial management system that meets the standards prescribed in the Uniform Guidance. NCCAP follows written financial policies which contain methods to determine the reasonableness, allowability, and direct allocation of costs. The agency has incorporated technology into its trusted practices, utilizing computerized double-entry accounting software for tracking financial information. These qualifications as well as a multitude of experience brought to the table by NCCAP’s finance team and track record to prudent financial management, demonstrate the agency’s ample capacity to manage federal grants.

North Central CAP proposes to expand supportive services in our current permanent supportive housing program to include funding for more supportive services and 1 additional unit in Wood County (leased by NCCAP) and operating expenses for potential 2 units not leased by our agency, but those who have obtained Section 8 housing by our community partners 1 unit in Lincoln County and 1 unit potentially in Wausau. We believe by providing intensive services we can help those PSH clients exit the PSH program more quickly to permanent housing because they will be more successful in attaining their goals and we feel that extensive case management will allow us to “hit the window” so to speak when a participant is ready to partake of services. We believe the “windows” happen frequently, but the opportunity to connect is not always available with current staff. More success and quicker success will allow us to enroll more clients into our current PSH program. The Landlords we work with in this program would like us to be able to provide more services more often to lower the number of incidents at these current units. This would expand our current PSH project in the coalition. No other agency provides permanent supportive housing.

The program will follow a Housing First model and will enroll additional chronically homeless participants with preconditions. Case managers will help participants find suitable housing by locating units near community amenities, ensuring rents meet FMR and Rent Reasonableness standards, and ensuring units meet Housing Quality Standards. Case managers will utilize a harm reduction approach to help participants maintain housing. For units that do not include utilities, NCCAP will pay the utilities and ensure the utility is in the participants name so they can establish good credit history. Clients will be encouraged to apply for energy assistance. NCCAP will hold the lease with this additional unit and the participant will sublease from us. If a landlord wants a participant out of the unit, we will locate another unit suitable for the participant to move into and negotiate with the landlord to resolve any issues that have occurred. This will allow the participant to avoid an eviction and will usually be a learning experience for them. The case manager will help participants identify goals to move toward housing stability and the plan will be individualized to each participants needs and preferences. The additional case manager hired will have further training to include substance abuse counseling and will be able to reach out frequently to be able to support clients as they need and when they need it.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

Case managers will meet with participants daily to assist in stabilization of housing, mental health, overall health, sobriety, employment, and other mainstream benefits by looking over the goal plan and providing necessary services/referrals as needed throughout their time in the PSH program. Some participants need daily connection with case manager to stay on track. When/if needed, CM can assist participants with life skills, soft skills, food, and transportation. If individuals are not receiving Social Security our SOAR certified staff can assist with SSI/SSDI applications should participants choose. This service may include writing and submitting applications, helping to secure required documents and providing transportation to required appointments. Referrals are made to community agencies for childcare assistance, education services, mental health services, legal services, outpatient health services and AODA services.

 - Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).
 - Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
 - Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
- B. VAWA Confidentiality Requirements. Examples of eligible costs for ensuring compliance with VAWA confidentiality requirements include:
- Monitoring and evaluating compliance.
 - Developing and implementing strategies for corrective actions and remedies to ensure compliance.
 - Program evaluation of confidentiality policies, practices, and procedures.
 - Training on compliance with VAWA confidentiality requirements.
 - Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.
 - Costs for establishing methodology to protect survivor information.
 - Staff time associated with maintaining adherence to VAWA confidentiality requirements.
