This project is a Housing First project that serves the homeless needs in our local communities by providing housing to our most vulnerable populations. This project focuses on serving those that are CH by definition and have a severe mental illness. This project serves both individuals and families. There continues to be need in these counties. The projected outcomes are to eliminate chronic homelessness in these counties served participant stability, developed support network, teaching advocacy skills, and increasing individual income and skills. This project's outcomes are that 80% will remain housed. Newcap coordinates with the local coalition to ensure connection with mainstream resources and community partners that assist with direction and support to program participants. Under the direction of Newcap, local member organize and deliver services to meet the specific needs of people who are homeless as they move to stable housing. Newcap takes the lead role in identifying additional resources needed to fill identified gaps in services. PSH shares possible grant opportunities and provides support for all members of the local coalition. Newcap is the ESG lead and we are the bridge between the State of Wisconsin, HUD Domestic Abuse Centers, homeless shelters, county service providers, and we are the lead agency in the BOSCO coordinated entry system in a 9 county region. CoC program support is needed because no other housing program provides permanent housing for the chronic homeless in these communities. The CoC funding will be used for housing location services, leasing, utilities that are not included in the rent, wage/fringe for staff, bus passes, life skills, purchasing furniture for apartments, repairs/maintenance, and administration of the grant.

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
