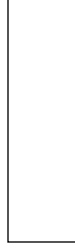

Newcap is a member of the WIBOSCOC which identified Brown County as being the community with the highest chronic homeless population in the balance of state in 2015. Newcap was awarded an award to purchase a duplex in Brown County. The initial project started in 2017. This duplex houses two chronically homeless families with many needs that have multiple barriers and needs to housing. These needs are: parenting classes budgeting food preparation housekeeping furthering education child care assistance & life skills. Referrals will be made to the agencies which provide these services in Brown County, some which are non-homeless providers such as mental health services, Brown County Human Services, UW Extension, Salvation Army, W-2 provider, etc. Newcap hired a .25 FTE Case Manager. This project identifies potential families using the Coordinated Entry system. The project is operated using Housing First model. Newcap projected outcomes are that all 2 families will stay in stable housing for at least one year & 65% of the families will increase their household income. Newcap case manager are all SOAR certified so they can work with each family to increase non-employment case benefits. Newcap is a partner member of the Brown County Homeless & Housing Coalition which is made of housing/service providers. This program is supported by the CoC because of Brown County's high homeless population & without this funding the program would not possible. The CoC funding will be used for housing location services, leasing, utilities that are not included in the rent, wage/fringe for staff, bus passes, life skills, purchasing furniture for apartments, repairs/maintenance, and administration of the grant.
