1. Provide a description that addresses the entire scope of the proposed project.

This project is a Housing First project that serves the homeless needs in our local communities by providing housing to our most vulnerable populations. This project focuses on serving those that are CH by definition and have a severe mental illness. This project serves both individuals and families. There continues to be need in these counties. We have extended this program to serve Brown County which is currently an underserved area because Brown County continues to show high numbers of chronically homeless individuals and families according HMIS and PIT data. The projected outcomes are to eliminate chronic homelessness in the counties served by 2020 and participant stability, developed support network, teaching advocacy skills, and increasing individual income and skills. This project's outcomes are that 80% will remain housed. Newcap coordinates with the local coalition to ensure connection with mainstream resources and community partners that assist with direction and support to program participants. Under the direction of Newcap, local coalition member organize and deliver services to meet the specific needs of people who are homeless as they move to stable housing. Newcap takes a lead role in identifying additional resources needed to fill identified gaps in services. PSH shares possible grant opportunities and provides support for all members of the local coalition. Newcap is the ESG lead and we are the bridge between the State of Wisconsin, HUD Domestic Abuse Centers, homeless shelters, county service providers, and we are the lead agency in the BOSCoC coordinated entry system in a nine county region. CoC program support is needed because no other housing program provides permanent housing for the chronic homeless in these communities.
