NWCSA is proposing to implement 9 units of scattered site leased units for permanent supportive housing. The program will follow a Housing First model & enroll chronically homeless participants without preconditions.

CMs will utilize a harm reduction approach in order to best help participants maintain housing. CMs will help participants find suitable housing by locating units near community amenities, ensuring rents meet FMR and Rent Reasonableness standards, & ensuring units meet HQS. CMs will assess each household’s barriers to maintaining housing stability. The CM will help participants identify goals to move toward housing stability. The plan will be individualized to each household’s specific needs & preferences. CMs will meet with participants weekly & assist in stabilization of housing, mental health, & sobriety as requested. CMs will connect participants to all appropriate mainstream resources & assist them in maintaining eligibility. CMs can provide case management, food, clothing, household furnishings, using mainstream benefits such as SOAR, SSDI and SSI ,mental Health Services AODA ,WIC services, maternal and childhood health services,and life skills training.

The goals of the project are to first stabilize the household within the unit and identify issues and barriers for the households. The ultimate goals of the program are 60 % to increase household income or increase access to noncash benefits and work towards finding and maintaining long term permanent housing outside of the program after there is no longer a need for the intensive case management services. The program hopes that 90% will exit to or maintain permanent housing.

CMs will continue to referral to community agencies for child care assistance, education services, employment assistance, mental health services, legal services, outpatient health services, & AODA services. CMs connect with the district’s Homeless Liaison to assist families with various resources, such as transportation, reduction of fees, and overall support to maintain the educational stability of the children.

CoC funding is required to provide a solid foundation for the program as well as future program growth and expansion. HUD Coc funding will used for leasing payments to landlords for the PSH units, to support 1 FTE of case management for program participants and administration. HUD CoC funding allows NWCSA to leverage supplemental support that provides the resources necessary to support the program and its participants. In this way, we can ensure that the needs of homeless households are being addressed, performance benchmarks are being met, funds are being maximized to serve the greatest number of homeless households in need, and the project is sustainable.

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in April 1968 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in section 509(a)(3).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.


