## Special Presentations: Presentation on hub by Karen Befus

Karen is the new HUB Coordinator. At this time, 4 people are handling HUB referrals with 2 locations: ADVOCAP(3)and Oshkosh Area Community Pantry (1). Karen's goal is to increase volunteer advocacy. HUB has 12 principal partners (\$25,000 investment/year) and 12 associate partners. The HUB Website was launched in June 2016. <a href="www.huboshkosh.org">www.huboshkosh.org</a>. Karen is working on a strategic marketing plan with co branding guidelines and materials. The Apricot database was launched in August 2016 and is making ongoing improvements. ADVOCAP coaching started in February 2016 and Oshkosh Food Pantry coaching started in August 2016. How to make a referral? In upper right hand corner, click Save Record. The referral is sent to a hub coaching site that you chose and you will receive notification within 2 days of an appointment set with referred. Paper referrals are also available and can be uploaded to the Website after filled in. HUB is not an immediate assistance or financial assistance program. HUB is for residents of the Oshkosh Area School District.

**WCRC-** TEDX Oshkosh is sold out for 10/29/16. Senior Expo will be on 10/17/2016. Elderly mediation training is planned for 11/3-11/5/16.

**Winnebago Landlord Association-** 70 people attended the Landlord /Tenant rights seminar on September 14<sup>th.</sup> 65 out of 70 people were landlords. Landlord training day is planned for 2/18/17 at UW Extension offices.

**Christine Ann Center-** Take back the night is tonight 10/5/16 at UW-Oshkosh Alumni Center at 5:30pm. Community agencies are working on establishing pillars for stopping human trafficking. Please call Cheryl if interested in being involved.

**Housing Authority-** The October Family Self Sufficiency newsletter was handed out. HA broke ground on the Cumberland Court Community Center last week. HA is completing rehab on the 40 Menasha scattered site units and will start to rehab other units in Neenah and Oshkosh. The plan is to complete 2 or 3 units per year.

**Legal Action-** As of August 15<sup>th</sup>, Legal Action will be assisting people to recover their driver's licenses that were suspended or revoked due to unpaid fines. Please call 233-6521. They are working on 4 cases at this time. Also taking referrals for evictions. Many cases are being dismissed because they are brought to court in the property manager's name and not the owner's name.
