The Salvation Army's Permanent Supportive Housing Program will provide twenty three units of housing to persons who are homeless and have persistent mental health issues. In addition to mental health issues many of the individuals we work with also have significant AODA issues. Our program model is a "housing first" model offering permanent housing as a first step towards stability. Services will be provided to 9 single individuals and 14 families. Priority will be given to chronically homeless individuals and families. Our program places no additional barriers to entry; there are no preconditions other than homeless and disability requirements. We work with the clients at their housing unit and offer services rather than require compliance. The majority of our program participant will come directly from shelters in our COC service area through our coordinated assessment system. A small percent of our clients come from the streets.

We are utilizing the Balance of State coordinated entry system to ensure we serve the most vulnerable individuals and families first. The VI-SPAT has proven to be an excellent tool in assessing the needs of our program participants. Including the duration of homeless with the information provided in the VI-SPAT has given us the criteria for determining priority for open slots in our program. In addition we are in compliance with the Balance of State written standards and prioritization policy.

The Salvation Army will lease scattered site units close to support services. Individuals/families do not need an income to participate in this program; however we will require folks with an income to contribute to their housing costs not to exceed 30% of their income.

Our services include a trained SOAR staff member to assist folks in preparing their Social Security applications. A qualified case manages will meet with program participants weekly to assist the family/individual with a self-sufficiency plan that meets their needs. All participants are encouraged to connect with mental health and health care services. Our goal is to work with each family/individual to apply for essential services that meets their needs. Our goal will be to provide permanent housing to 90% of our program participants and see 76% of our clients maintain or increase their income. As these goals are achieved families and individuals will become stable and less reliant on governmental services.

Due to our location in a rural area funding is limited from private funders and foundations. A program of this size would be impossible to support without COC funding. We have been able to secure appropriate match for our project, the additional funds to add other case management services and SOAR services.


