Hartwell Street Apartments is a permanent supportive housing project located in Elkhorn, Wisconsin. The project is one building that consists of ten one bedroom units and four efficiency units. Hartwell Street Apartments target population to be served will be chronically homeless individuals meeting the HUD definition of disabled. The population will come primarily from the street, sleeping in cars, sleeping in the woods/fields or emergency shelters. Hartwell Street Apartments follows the Balance of State COC approved prioritization and coordinated entry process, by using the VISPDAT to identify clients that meet the chronically homeless definition. Our focus is on using the Housing First Model to quickly move eligible participants into the program by having low barriers for entry.

Hartwell Street Apartments will provide eligible supportive services. Each participant has the opportunity to meet weekly with the case manager. Every participant is encouraged to create an individual plan that identifies needs, personal issues and goals. The plans will be updated and changed as the needs of the participant change. The case manager will use these plans to help organize educational opportunities, find community resources, and create learning and hands-on workshops for the participants. The case manager will also assist participants in maintaining mainstream benefits they may be receiving. At this time, there are no additional service participation requirements for program participants.

Hartwell Street Apartments will meet projected program outcomes in the categories of housing measure and income measure. 93% of participants are projected to remain at Hartwell Street and 86% of participants will maintain their income or increase their total income. The majority of our participants receive SSI/SSDI income benefits. Residents are still given the opportunity to explore other income opportunities with or without the assistance of the Case Manager.

Hartwell Street Apartments is the only program of its kind in our county. By working closely with other local service providers, we have identified the need to provide a permanent housing opportunity to the chronically homeless. Partnerships that will be used are with Walworth County Division of Health and Human Services, UW Extension, RESCARE, VA, local Job-Center, Twin Oaks Homeless Shelter, CAI, Men’s Traveling Shelter, local faith-based organizations, domestic violence advocate program, local businesses and community organizations.

The COC grant allows residents the opportunity to have a safe, decent place to reside in a long-term supportive environment, the opportunity to maintain their health and medical welfare in regards to their disability, access to financial resources to address some basic needs, and the ability to be empowered to be as independent as possible. If the program was not offered, the participants would continue to experience homelessness.
