Action Plan #4 These were the previous Goals developed in 2022

- With the help of the Coalition, HAC was able to submit Action Plan #4 ahead of the deadline to the WIBOS. Below are the topics that were chosen.
 - Public Housing Authorities (PHA) Determine ways to support the Waukesha Housing Authority (WHA) and the implementation of having a homeless preference. Also, discuss the possibility to expand on Coordinated Entry. Expanding the options for individuals and households in shelters to exit to permanent housing with the help of CE and WHA.
 - Protecting Against Discrimination There is always the opportunity for growth and learning in this area. Additionally, I am not aware of culturally specific LGBTQ+ agencies in Waukesha County that are available for support or advocacy. Historically, marginalized populations who do not have

Discussion surrounding the previous plan that has an extension and creation of a new plan.

K. Fisher suggested we not attempt to take on too much -

- ongoing access to providers with cultural humility or competence can experience additional, and at times, more significant barriers.
- Accessing mainstream benefits It is becoming increasingly difficult for individuals and households to access medical and mental health services promptly. And to the goal above, there are very few culturally competent or culturally specific providers.

We need to Create our ACTION PLAN 2.0 which focuses on DEI in Homeless Services for the 2023 year. The Coalition started with the noted identification of goals/processes to start.

Creating either of these committees would assist in fulfilling our COC Action Plan 2.0 To better align our Coalition priorities with our funders' expectations, HAC would like the Provider Collaborative to consider the creation of a committee called RED (Racial Equity & Data Committee) to address racial disparities in housing and homelessness and to advance racial equity in our community. Some of the key concepts of this committee would be to identify the different levels of racism such as interpersonal, institutional, and structural/systemic. What is equality vs. equity vs. justice? Evaluate what data looks like in Waukesha. 	

	HAC would also like the Provider Collaborative to consider the creation of the <i>Housing Solutions & Strategies Committee</i> to address the current crisis of a lack of affordable and safe housing in Waukesha County. Some of the objectives could be to explore permanent, affordable housing options, and shared-housing models, utilize creative strategies to address housing affordability and discuss inclusionary zoning regulations/options.	
EOS Update (Emergency Overflow Shelter)	 Averaging approximately 20 people per day Regular meetings with all shelters/people involved has improved overall communication and referral flow People are exiting the EOS to their Referring Shelter CLOSURE DATE – Monday, April 3, 2023 (some flexibility if needed) Wind down meetings scheduled for March 10 and March 28 will all providers of supports. EOS may be rented by other community Shelter Providers during the off season. This would help provide a revenue stream to be used in the EOS Season. 	Patricia Fabian
HAC Updates	 EHH 2022-2023 Monitoring HAC will be engaged with DEHCR for the annual monitoring as the Lead Agency and its sub-recipients, which include Community Action Coalition, Hebron Housing Services, and The Salvation Army. On Site Monitoring is scheduled for Monday, March 27th beginning at 9:30 AM. SSHG funds were awarded late in 2022 to be used by 4/2023. Will be put towards EOS Operations. \$21,000 SSSG funds were awarded in the amount of \$6,000. These dollars will also support the EOS Operations. This dollar amount is significantly less than in prior years due to the low bed count (shelter use) last season. EOS was in operation approximately two months. This year it is in operation for 4.5 months. HOME Grant: just approved last week by the Committee. Received a grant for \$40,000 in 2023 to help pay the Administration costs at HAC. CBDG Grant process: has just begun and will be submitted by March 10, 2023. 	Patricia Fabian
