LSS proposes to provide PH-RRH that will address the core components of RH including housing identification, move-in and rent assistance, and RRH case management and services. Services will be focused on the large number of single youth ages 18-24 and adults aged 18 and older currently prioritized for RRH services; this particular population is currently showing the greatest length of stay in shelter as well. The Welcome Home Eau Claire (WHEC) program will focus housing identification services on assisting homeless households securing permanent housing quickly despite issues that may make this challenging. In addition to working with local landlords, the case manager (CM) will also educate clients on issues relevant to maintaining permanent housing to ensure that clients have the skills to remain in housing for the long-term. Next, the CM will provide the client with short-term rent and move-in assistance and will connect them to services that will allow them to stabilize. The CM will assess client needs and may assist in paying security deposits, rent, utility deposits, or other move-in expenses; this assistance is provided without preconditions. Once housed the ability of households to address their needs, including securing or increasing income, will be greatly improved. The CM will continue to assess household needs and to individualize assistance. RRH services will support participants as they stabilize in housing; and will connect households to mainstream services and community supports that will assist them in meeting their needs. As the WHEC CM will only provide short-term support and assistance, it will be essential to housing stability and permanence for the household to develop/build upon an ongoing support system. RRH case management services are highly individualized and designed to address the specific, short-term needs of households by connecting them with supports and services. Anticipated program outcomes: Average time from program entry to housing placement will be 60 days; 80% of participants will remain in permanent housing; 80% of adult participants will maintain or increase their total income. LSS will coordinate with other organizations to ensure that all client related housing and supportive service needs are met. LSS will expand upon existing partnerships to develop services to meet client needs including coordination with mainstream benefits providers, county services departments, local landlords, mental and physical health care providers, legal services, schools, employment and educational programs, social service providers, and CoC member agencies. CoC funding is required to provide a solid foundation for program implementation and program growth and expansion. HUD CoC funding will allow LSS to establish a small, manageable project that will begin to address the needs of those homeless households prioritized for RRH. CoC funding will also allow us to leverage supplemental support.
