Less than 1% of the recently expired grant was unexpended. We saw a decrease in the amount spent on leasing because several of our households moved to 1 bedroom units due to changes in family size.

Since implementation of CE and Priority Lists, we have identified more CH HHs. Most of those identified have AODA issues & all have MI. Many CH in our area have drug charges on their records, making it difficult to find housing without assistance. Many are also involved in Child Protective Services. Additional challenges include the absence of public transportation in our counties and limited jobs that provide a living wage for people without post-secondary education.

The project follows a Housing First model & enrolls CH participants without preconditions. CMs utilize a harm reduction approach in order to help HHs maintain housing. CMs help participants find suitable housing by locating units near community amenities, ensuring rents meet FMR & rent reasonableness, & ensuring units meet HQS. CMs negotiate with LLs to include utilities in the rent. For units that do not include utilities in the rent, we pay the utility company directly. We hold the lease on the unit & pay the full rent to the LL. Participants sublease the unit from us & pay rent equal to 30% of HH's adj. monthly income. If a HH is in jeopardy of eviction, we help find a new unit through housing search & assist. w/moving costs. Term. from the proj. is rare & limited to severe breaches of the participation agreement or violence against staff.

Once housed, CMs & participants assess barriers to maint. housing, develop a housing stability plan, determine the frequency of visits (min. weekly), & identify comm.. resources to which the individual/family can be referred. Based on the individual/family's needs, CMs will connect to all appropriate mainstream resources & assist in maintaining eligibility throughout PSH. CMs can assist participants with life skills, food costs, transportation, job readiness skills, & ed. attainment. CMs are SOAR trained for assist. w/ SSI/SSDI applications.

As a scattered site project, we help participants transition in place at the end of their program. This maintains housing stability & connection to community resources. We have 10 HHs enrolled in PSH at maximum capacity. We project that 90% of participants will exit to, or remain in PH. We project that 67% of program participants will increase their total income. This will be accomplished through assisting participants in obtaining SSI/SSDI.

We rely on partners for referrals to PSH through CE. We refer participants to other agencies for child care assistance, education services, employment assistance, mental health services (including DV counseling), legal services, outpatient health services, & AODA services.

HUD & WI BOSCO support is essential in ending chronic homelessness in our area. The HHs experiencing homelessness in our area have many challenges, most significant of which is AODA. We lack subsidized housing & long-term



supports for people with MI &/or AODA. This project provides intense CM & supportive services to help these HHs obtain & maintain permanent housing.
