We had unexpended funds due to challenges getting participants into housing. Midway through the grant we hired a Housing Coordinator to increase our success rates with finding housing for participants. We did see our housing placement rates increase, but we were still unable to expend all of our funds. We do not expect this to be an issue moving forward.

In Western WI, we are facing a methamphetamine epidemic. People not only use meth, but make it as well, creating long-term environmental damage to their homes. For this reason, landlords are unwilling to rent to people who have criminal charges related to the use, manufacture, or distribution of meth. Many of the people experiencing homelessness in our area have these charges on their records, making it all but impossible for them to find housing or jobs without assistance. They are also involved in Child Protective Services, having had their children removed due to the impact of their meth use. Additional challenges include the absence of public transportation in our counties and limited jobs that provide a living wage for people without post-secondary education.

The project follows a Housing First model & enrolls households with & without children without preconditions. CMs utilize a harm reduction approach in order to best help participants maintain housing. CMs help participants find suitable housing by locating units near community amenities, ensuring rents meet FMR & rent reasonableness, & ensuring units meet HQS. CMs negotiate with landlords to include utilities in the rent. If a household is in jeopardy of eviction, we assist them in finding a new unit through housing search & assistance with moving costs.

Once housed, CMs & participants assess barriers to maintaining housing, develop a housing stability plan, determine the frequency of visits, & identify community resources to which the individual/family can be referred. Based on the individual/family's needs, CMs will connect them to all appropriate mainstream resources & assist them in maintaining eligibility throughout RRH. CMs can assist households with life skills, job readiness skills, educational attainment, & transportation. CMs assist participants to become employable, refer participants to TANF services, & provide SOAR services to obtain SSI/SSDI.

We expect to have 18 households enrolled in RRH at maximum capacity & to serve 36 households during the program year. We project that 80% of participants will exit to, or remain in, permanent housing. We project that 30% of households will increase their total income.

We rely on our partners for referrals to RRH through Coordinated Entry. We refer participants to other agencies for child care assistance, education services, employment assistance, mental health services (including DV counseling), legal services, outpatient health services, & AODA services. HUD and WI BOSCO support is essential in implementing this project. The households experiencing homelessness in our area have many challenges,

most significant of which is substance abuse. This RRH project can provide intense case management & supportive services to help these households obtain & maintain permanent housing. We use ESG funding to rapidly re-house households with fewer barriers to housing stability, and HOME-TBRA funding to rapidly re-house transition-age youth.
