### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The population we serve in Western WI faces several major challenges to stability, the meth epidemic & mental health crisis being two of the greatest. The production & use of meth creates long-term environmental damage to homes & family structures, while mental health resources are few and inaccessible. all of which often leads to loss of already limited income. Many of the people experiencing homelessness in our area have criminal charges related to the use, manufacture, or distribution of meth, and/or little to no income, making landlords & employers wary & employment & housing very difficult to obtain. Additional challenges include the lack of public transportation in our counties (which are rural & car-dependent) & the lack of attainable living-wage jobs. To best address participants' needs, the project follows a Housing First model & enrolls HH without preconditions. CMs utilize a harm reduction approach to help participants maintain housing. They help participants find suitable housing by locating units near community amenities, ensuring rents meet FMR & rent reasonableness, & ensuring units meet HQS. CMs negotiate with landlords to include utilities in the rent & if a HH is in jeopardy of eviction, assist them in moving.

Once housed, CMs & participants assess barriers to maintaining housing, develop a stability plan, determine the frequency of visits, & identify useful community resources. Based on the HH's needs, CMs will connect them to all appropriate resources & assist them in maintaining eligibility throughout RRH. CMs can assist HHs with life skills, job readiness skills, educational attainment, transportation, refer participants to TANF services, & help them obtain SSI/SSDI.

Based on program history & details, we expect to have 18 HHs enrolled in RRH at maximum capacity & to serve 36 HHs during the program year. We project that 80% of participants will exit to, or remain in, PH and that 30% of HHs will increase their total income.

Our program is strengthened by collaboration. We rely on our partners for referrals to RRH through Coordinated Entry & we refer participants to other agencies for childcare assistance, education services, employment assistance, mental health services (including DV counseling), legal services, outpatient health services, & AODA services.

HUD & WI BOSCO support is essential in implementing this project. The HHs experiencing homelessness in our area face many challenges that are difficult or impossible to overcome without support. CoC Program funding will be used to provide rental & security deposit assistance, as well as supportive services to participants, thereby allowing this project to provide intense case management & supportive services to help these HHs obtain & maintain permanent housing. We use ESG funding to rapidly re-house HHs with fewer barriers to housing stability, & HOME-TBRA funding to rapidly re-house transition-age youth.
