Western Dairyland PSH 1 is a renewal PSH project addressing the needs of the chronically homeless (CH) in Eau Claire, WI. Our PSH project is the only program available to the CH in the area. We strive to focus on helping the CH individuals and families access and sustain permanent housing.

Our program follows the Housing First model and offers the CH clients housing without preconditions, such as sobriety, mental health treatment, or minimum income. We do not require service participation, rather accept applicants regardless of their sobriety/use of substances, completion of treatment, or participation of services. Applicants are chosen from the top of the Coordinated Entry list and by use of the BOS Order of Priority (length of time homeless and VI-SPDAT score).

We currently lease 15 units for both singles and families in a scattered site project. These units house approximately 21 of the CH population. Our program provides services including transportation assistance, case management, employment and education services, life skills training, and various supportive services. When able, we assist clients with increasing their income in a move toward eventual self-sufficiency. Getting at the root of their causes of homelessness and working with them to overcome those issues is a priority. We often work with other agencies in order to meet their significant needs. Our relationships with Comprehensive Community Services (CCS), Community Support Program (CSP), Inclusa, the Aging and Disability Resource Center (ADRC), and others allow us to address their needs at a much higher level. Collaborating with others provides more comprehensive services and contributes to the success of the clients.

While our goal is to have 82% of our PSH clients exit to permanent housing destinations once they are ready, the reality is that the clients we are serving tend to have more significant challenges. They are being evicted from their units for lease violations. But because we operate under the Housing First model, we continue to re-house them in an effort to work with them longer, and address their needs further.

We have similar problems in increasing income. Our goal of employment is equally hard to meet. We strive to see 56% either increase their cash or non-cash income, but often fall short of that goal. Realistically, the clients are coming into the program with such high untreated mental health or AODA issues that they are not able to work. Some enter the program already receiving SSI/SSDI, and rarely see an increase in their benefit. Others have had their benefits revoked. Those not receiving social security are assisted with getting the benefit, but the timeframe is often long. Often it takes several attempts to receive benefits. In some cases, it took years before clients were approved. All of these issues often interfere with meeting our goal for income.
