We have only submitted one APR back in 2018 for this grant. Our newest grant just ended 7/31/19, and we were unable to get all of the fiscal reporting done in time to submit a new APR for ranking purposes for this NOFA. So, during the first year of operation, we were unable to do a budget mod. This last year, we did shift dollars from leasing into supportive services, resulting in more funds being spent.

WD proposes a renewal PSH Project to address needs of the chronically homeless in Eau Claire, WI. The agency will rent 5 scattered site units (4 single, and 1 -3 bedroom). The units will house approximately 8 of the area's most chronically homeless.

Program goals include 82% of persons housed will remain in PH or will exit to permanent housing at the end of the operating year. Additionally 56% of adults will maintain or increase their total income at the end of the operating year or project exit.

WD will prioritize assistance to those most in need by referring to the Dairyland Coordinated Entry Prioritization List and BOS Order of Priority. This project is modeled after Housing First, focusing on helping individuals & families access & sustain permanent housing as quickly as possible without time limits and offering services to promote housing stability.

Besides these 5 units, we also provide an additional 15 units of PSH in Eau Claire. Housing First will be offered to individuals without pre-conditions or participation requirements. The primary goal will be to provide rapid placement in permanent housing. Once housed, staff will offer a vast range of supportive services in an attempt to address barriers. In following the Housing First model, services will not be mandated. Similarly, their housing status will not be affected by their participation or lack thereof.

We are requesting funding for a 1 year renewal project to include leasing, case management, operations, supportive services & admin. Funding from the COC is necessary in order for us to continue housing this difficult population. We currently offer the only housing program for the CH in Eau Claire. Without our services, and our ability to house 20 households, there would be that many more households living on the streets. Chronically homeless individuals and families often have barriers to obtaining & maintaining permanent housing including substance abuse problems, mental health issues, unstable employment histories, and a lack of financial competency. Consistent with the Housing First model, our PSH program will place its highest priority on housing these individuals in stable, permanent housing and then given access to an array of supportive services including: transportation assistance, case management, employment and education services. Referrals to the non-partner agencies will address subsequent barriers:

- Lutheran Social Services (LSS):AODA & mental health case management
- Catholic Charities:budgeting & financial assistance
- The Community Table:1 meal daily for those suffering from food insecurity
- Wellness Shack:mental health meetings/support

- Vantage Point:mental health and AODA
- LE Phillips:detox and outpatient AODA
- Career Development Center (CDC):vocational/employment opportunities for individuals with disabilities or disadvantages
- New Journey Program:Mayo Clinic- AODA outpatient treatment
- CSP:mental health case management
