3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Western Dairyland EOC, Inc. proposes to expand its PSH program by 10 units in Eau Claire, WI. The agency plans to rent 10 one-bedroom apartments in a scattered site setting. The units will house 10 of Eau Claire's most chronically homeless population. According to recent data from the Dairyland CE prioritization list, there are 34 chronically homeless on the list.

WDEOC will prioritize assistance to those who are identified as the most in need by referring to the Dairyland Coordinated Entry Prioritization List, non-WISP list, and Order of Priority developed by the BOS COC. The expansion would be modeled after the Housing First approach, with a focus on helping individuals access and sustain permanent housing as quickly as possible without time limits and offering services to promote housing stability. At present, we provide 20 units of PSH in the City of Eau Claire. Housing First will be offered to qualifying individuals without pre-conditions or service participation requirements. The primary goal will be to provide rapid placement into permanent housing. Once housed, we will offer a vast range of supportive services in an attempt to address their individual barriers. However, in following with the Housing First model, in no way will those services be mandated. Similarly, their housing status will not be affected by their participation or lack thereof.

With this in mind, we request funding for a 1-year renewal project. Chronically homeless individuals and families in the Eau Claire area often have barriers to obtaining and/or maintaining permanent housing, including: substance abuse problems, mental health issues, unstable employment histories, and a lack of financial competency. Consistent with the "Housing First" model, our PSH program will place its highest priority on housing these individuals in stable and permanent housing after which residents will be given access to an array of supportive services in an attempt to address their individual barriers. These services will include transportation and transit assistance, case management, employment and education services, all of which will address unstable employment histories; further, financial counseling (part of life skills training) from WD staff will address the lack of financial competency.


