Good afternoon,

The BOS was recently informed that the YWCA in the Coulee Coalition is relinquishing their COC RRH grant. That means there is \$77,466 on the table in the current COC Project competition. Please understand that there is a tight turnaround for this decision because we have a deadline of 10/16/21 for required esnaps submission.

As such, we need to either-

- (a) leave those funds on the table and lose them or
- (b) conduct a board vote to use the funding to expand our CE grant (as a new project, expanding our current renewal to add in two coalitions (Jefferson and East Central) of the BOS currently not covered by the SSO CE grant)

I would like to make a motion that we use the \$77,466 to expand our CE grant as a new project, expanding our current renewal to add in the Jefferson Coalition and East Central Coalition of the BOS currently not covered by the SSO CE grant.
